

Technical Updates Corner–FASAB and GASB

Federal Accounting Standards Advisory Board (FASAB)

December 14, 2017—FASAB issues an Exposure Draft on Classified Activities

The Board is proposing guidance to protect classified national security information or activities from unauthorized disclosure in a publically issued General Purpose Federal Financial Report. This proposal represents the first step in balancing the need for financial reports to be publicly available with the need to protect classified information from public disclosure. This proposal would permit component reporting entities to provide GPFFR to the public by including limited modifications necessary to protect classified information from disclosure. This would allow financial presentation and disclosure to appropriately accommodate end user needs in a manner that does not impede national security.

The Board requests comments on the exposure draft by March 16, 2018, and encourages respondents to provide responses to all of the questions raised and the reasons for their positions. The exposure draft and the specific questions raised are available at the FASAB website in PDF and Word format, respectively (http://www.fasab.gov/documents-for-comment/).

Governmental Accounting Standards Board (GASB)

GASB REQUESTS PUBLIC INPUT ON REVENUE AND EXPENSE RECOGNITION

Norwalk, CT, February 1, 2018—The Governmental Accounting Standards Board (GASB) has issued for public feedback an <u>Invitation to Comment</u> (ITC) on the development of a comprehensive revenue and expense recognition model for state and local governments.

The GASB's objectives in developing a comprehensive model are:

- To create a more robust framework to address a wide range of transactions, including some for which no guidance exists at present
- To improve the comparability of how transactions are accounted for and reported by governments
- To provide more useful information to users of financial reports for making decisions and assessing accountability.

The ITC, *Revenue and Expense Recognition*, discusses two models: an exchange/nonexchange model, and a performance obligation/no performance obligation model.

The exchange/nonexchange model includes a classification process based on the existing definition for exchange transactions. The recognition process in this model would be based on existing guidance for nonexchange transactions and a standardized recognition approach for exchange transactions.

Interested parties are asked to review and provide input on the document by April 27, 2018.
