## April 11, 2006 Meeting

Cindy Stein called the meeting to order and requested self-introductions from everyone. Deb Burling introduced this year's scholarship recipients and indicated the scholarship checks would be mailed directly to the student's schools in July. The minutes were read and approved as read. The treasurer's report was approved as read. Cindy indicated it might still be possible for the national AGA to underwrite the hotel costs for two of our members to attend the June conference in San Diego.

Jerry Mitchell rescheduled the community service at the Ravenwood Assisted Living Center at 10 AM on April 29, 2006. He explained we would be contributing small items for gift bags for the residents.

Cindy indicated the Regional Vicepresident was unable to attend this meeting due to a work conflict, but hoped to be at May's meeting.

Cindy asked Dr Nichols to contact IMA for their summer meeting schedule. She noted there would be a noon meeting of the Executive Committee on April 24, 2006. Dr Nichols mentioned next month's speaker would be Dr James Brown, regarding SAS 99.

Deb Gillenwaters introduced our speaker Evelyn Honea. Evelyn is Assistant City Manager for the City of Springfield. She has also served as Director of Information Systems and Assistant Director of Finance. Evelyn discussed the status of the Police Officers' and Fire Fighters' Pension Plan. She gave a handout detailing her discussion and a handout listing questions regarding the suggestions for solving the problems associated with the pension plan.

There has been a drop in the funded ratio of the plan from 80% in 2000 to 52% in 2005. The three components of the plan that impact the funded ratio are: investment returns and expenses, contributions, and benefits. The investment returns have been markedly low and in fact in one year the fund lost money. For the first time the city did not make the recommended contribution and the short fall is \$523,000. This is due to the large increase in recommendations. The shortfall is anticipated to be \$2.8 million by June 30, 2006. Retiree benefits are a vested property right and may not be changed without a vote of the citizens.

Evelyn reviewed several plan provisions for participants hired after May 15, 2006. The amendments were listed in the handout she provided. She emphasized the current employees would not be affected by the amendments, but indicated the current employees are not comfortable with the suggestions. Current employees seem to only regard maintaining the status quo as acceptable.

Evelyn opened the floor for questions and answered all those asked. She also reviewed the questions she had listed in the handout. Cindy thanked her for an excellent presentation and adjourned the meeting.

CPA Executives Say U.S. Companies Can't Continue Offering Adequate Pensions
The vast majority of CPAs serving as corporate CEOs, CFOs, controllers and in other
executive positions believe American companies can't continue providing pensions that
adequately cover their employees' retirement years, according to the results of a <a href="mailto:new survey by the AICPA">new survey by the AICPA</a>. Moreover, many CPA executives believe reductions in pension
benefits pose a threat to a company's ability to attract and retain the talent they need to
compete. According to John Morrow, vice president of the AICPA's division for CPAs in
business and industry, "The traditional system of rewarding employees with pensions
after long years of service is on its way out, because companies simply cannot bear the
cost. Therefore, employees will have to find alternate methods of funding their

# TOYOTA AND LEXUS VEHICLES CERTIFIED FOR NEW ENERGY TAX CREDIT

WASHINGTON — The Internal Revenue Service has acknowledged the certification by Toyota Motor Sales U.S.A., Inc. that the Toyota Camry Hybrid and Lexus GS 450h Model Year 2007 vehicles qualify for the hybrid tax credit enacted by the Energy Policy Act of 2005. The tax credit for hybrid vehicles applies to vehicles purchased on or after January 1, 2006, and may be as much as \$3,400 for those who purchase the most fuel-efficient vehicles.

The hybrid vehicle certifications recently acknowledged by the IRS and their credit amounts are:

- 2007 Toyota Camry Hybrid \$ 2,600
- 2007 Lexus GS 450h \$ 1,550

Starting in 2006, this tax credit replaces the tax deduction of \$2,000, which was previously allowed for taxpayers who purchased a new hybrid vehicle before December 31, 2005 for the clean-burning fuel deduction. The tax credit requires a different certification. Many currently available hybrid vehicles may qualify for this new tax credit.

Consumers seeking the credit may want to buy early since the full credit is only available for a limited time. Taxpayers may claim the full amount of the allowable credit up to the end of the first calendar quarter after the quarter in which the manufacturer records its sale of the 60,000th vehicle. For the second and third calendar quarters after the quarter in which the 60,000th vehicle is sold, taxpayers may claim 50 percent of the credit. For the fourth and fifth calendar quarters, taxpayers may claim 25 percent of the credit. No credit is allowed after the fifth quarter.
