PRESIDENT'S MESSAGE

The second quarter of our Program Year has been the busiest, as always, with our annual Professional Development Training (PDT). In October we held our 33rd annual PDT which was very well attended and provided many great CPE opportunities! This year's PDT offered a variety of topics relevant to state, local and special district governments, as well as their private sector partners. We once again offered many nationally known speakers on current topics from GASB, federal OMB, NASACT, and the CEO of National AGA. This event was a must attend event for AGA members and other in the government accountability industry!

At this year's PDT we awarded our second annual Excellence in Government Leadership Award. We presented this award upon a unanimous decision of the Executive Committee to Hugh J. Dorrian, the now retired City Auditor for the City of Columbus. Mr. Dorrian's accomplishments include, holding the office of City Auditor for 12 consecutive terms beginning in 1969, maintaining a AAA credit rating for the City of Columbus, overseeing the issuance of \$34.8B in municipal securities issuances, achieving Columbus voter approval of 78 of the 82 bond issues placed on the ballot during his terms, and earning the CAFR award for 38 consecutive years. Mr. Dorrian truly exemplified excellence in government leadership and left a lasting impression on everyone that has been fortunate enough to work with him.

In my message last quarter, I mentioned that we would be attending meetings with Ohio State University and Ohio Dominican University to talk with students about careers in governmental accounting. Both of those meetings went really well and the students were very engaged and asked good questions about our field. Based on the recommendation of a member we have scheduled another meeting with accounting students at Ohio Wesleyan University in the spring. If any other members have contacts with local colleges or universities that you think would want to have us present, please reach out to me and let me know. Thank you to Marni Hall and Will Kays (Greater Columbus Chapter President) for attending these meetings with me!

The upcoming month of March is Certified Government Financial Manager (CGFM) month. Our Governor each year proclaims the month of March as CGFM month to recognize the Certification Program, which is nationally recognized as one of the most respected certifications for those who work in Federal, State or Local government. Our chapter supports the CGFM by offering study guide review courses throughout the year. Please consider looking into the CGFM certification and for our other upcoming review sessions.

We are always looking for members interested in volunteering on our Education Committee. If you are interested, please reach out to me. Also, if you have any suggestions for future training topics or speakers, please send those my way as well some of our best speakers have come from chapter members like you who make recommendations of outstanding speakers you have seen at other conferences.
