Volunteer for the American Red Cross New Finance Disaster Response Team

The American Red Cross invites CPAs to join its new Finance Disaster Response Team to ensure proper stewardship of donor dollars during large-scale disasters. Current members of the FDRT include more than 90 Red Cross employees and partnership organization volunteers. These individu-

als are trained in the key internal control procedures that must be in place during a disaster relief operation. The Red Cross pays trip expenses including flight, hotel, rental car, food, etc. CPAs have recently been deployed to the Calif. wildfires and the severe flooding in Tex., Okla. and Kan. As members of

Dashboards Simplify Performance Reporting

DASHBOARD IMPLEMENTATION AT THE TRANSPORTATION IMPROVEMENT BOARD

The TIB is an independent state agency created by the legislature in 1988 to address the escalating demand for roadways as urban development increased. The agency awards \$80 million per year in competitive grants to cities and urban counties for street and sidewalk projects.

In early 2001, the TIB was about 95 percent over-programmed; too many grants had been awarded and the bill was coming due. For 10 years, hundreds of project schedules were adjusted by hand on a huge pad of paper spreadsheets to control \$600 million in expected billings. The new agency director discovered on his fourth day on the job that many agencies would not be paid until the new fiscal biennium, five months away. On day five, the new mission of the agency became clear, recover from the likely default and never allow this to happen again. Most importantly, decisions would have to be carefully rationalized against supporting data.

In 2002, the staff and board completed a balanced scorecard strategic plan and adopted new financial and project performance measures. Key benchmarks evolved from the scorecard initiative. The project inventory needed to be reduced by about 400 projects. Total obligations, then at \$655 million, should be no more than \$380 million. The agency set performance targets and began to pursue the resolution of about 200 long-

delayed projects. Excessive obligations were moderated through withdrawals and curtailing previously uncontrolled funding increases.

The data from 12 years of project activity represented a unique information warehouse that formed the foundation for the TIB's business intelligence initiative. By 2003, the TIB had automated many data reporting steps and this evolved by the end of the year into the agency's first performance dashboard. The TIB's dashboard displays metrics, graphs, and maps from data extracted from an extensive SQL project tracking system. The dashboard runs on an Intranet Web site providing instant access to all staff. By the end of 2007, certain dashboard pages will be available on the external Internet pages to provide best practices and les sons learned to other agencies.

A dashboard is a reporting tool that must be fed by a data source. A data feed is used to link the dashboard to

the SQL database in the same way CNN and other news organizations feed new updates to users subscribing to RSS feeds. The dashboard refreshes data each time a Web page loads, ensuring

that the user always views the most current information. The TIB also employs several user interfaces to insert data directly into the dashboard to allow use of data not stored in the SQL database. For example, financial data from statewide systems are transferred to the dashboard through a user interface. Dashboards can be driven by Excel spreadsheets as well; however, con-

nection to a database is highly recommended to achieve greater functionality and less duplicative data entry.

At the TIB, a single in-house information technology specialist with advanced coding skills built the dashboard using commercial software. In-house development provided advantages of high familiarity with agency business and the same programmer who developed the SQL database. Hundreds of hours of staff time went into identifying and perfecting performance measures and linking them to strategic initiatives. The total cost for the TIB's

vided. Using an outside consulting firm could save considerable staff time devoted to developing a system and could be well worth the cost for the expertise in balanced scorecard and perform-

ance measurement. Dashboard development at the TIB has continue d throughout the four years since initial use. New applications, like Go ogle mashups, have been developed and some charts have been discarded in favor of more useful data.

CEC Minutes November 15, 2007

On November 15th the officers gathered at the Parks Department conference room for a board meeting. Justin, Linda, Jerry, Deb G, Deb F and Teresa were present. We discussed future speakers for the next 6 months and the spring ½ day seminar. Deb G suggested an officers' retreat/planning meeting for the spring, possibly in March, for the AGA recognition program. The state of Arizona, the city of Schenectady (NY), the state of Nevada, the city of Albany, NY, the state of West Virginia and the city of West Valley, UT, are the latest governments to join a growing list of state and local governments and federal agencies that are producing four-page Citizen-Centric Reports and answering the call for fiscal accountability and transparency.

The four-page annual "state of the government" reports are designed to be visually appealing, provide understandable information to citizens about the performance and financial condition of the govern-

ment as well as demographics and future challenges while answering the question, "Are we better off today than we were last year?"

Democracy is all about engaging the citizenry in the operations of government. We believe the AGA Citizen-Centric Reporting model provides more useful and timely information to our citizens thereby engaging taxpayer participation. If your government is not producing a Citizen-Centric Report, please help convince them to do so. All the tools you need to start the process can be found on the <u>AGA website</u>.

This document will improve governmental financial and performance reporting to citizens. As the thought leader for government accountability, we feel that this task is AGA's responsibility. If we do not do this, who will?

CNN - In a pair of landmark studies, two groups of scientists announced Tuesday that they have reprogrammed human skin cells to act like embryonic stem cells, whose potential to mature into any other kind of cell in the body may ultimately prove key to curing a number of diseases, without the use & destruction of embryos.

Stem cell research is not banned. Private research using embryonic stem cells is allowed, but federal money -- the largest single source of funding for such work -- is limited to research involving embryonic stem cells that were created before August 2001, when Bush announced that federal funds could be used only for work on lines already in existence.
