## LUNCHEON PROGRAM

**SPEAKER:** Ms. Nancy M. Gordon  
Congressional Budget Office

**TOPIC:** "The Context for Considering  
Health Care Reform"

Many people think that the United States health care system is in disarray--costs are extraordinarily high, yet 35 million people are without health insurance. Moreover, control of health care costs is necessary if we are to control the federal budget deficit and enhance the economy's performance.

- Why is the U.S. the only industrialized country that faces such problems?
- Are there ways to deal with these problems without giving up many of the desirable features of our current health care system?

These are some of the very relevant questions our speaker will consider in addressing this timely and controversial federal financial topic.


Ms. Nancy M. Gordon is currently Assistant Director for Health and Human Resources of the Congressional Budget Office (CBO). The CBO is a nonpartisan organization mandated to provide the Congress with budget-related information and analyses of alternative policies. Her division is responsible for preparing reports and testimony for the Congress in areas such as health, social security, welfare, education, and employment. Recently, over half the division's staff have been analyzing the likely impacts of a number of proposals to restructure the health care system.

Before coming to the CBO, she was the Executive Director of President Carter's Interdepartmental Task Force on Women and then a Senior Advisor to Sarah Weddington, Assistant to the President. Prior to that, she was a Senior Research Associate at the Urban Institute. Her research there focused on the treatment of women under the Social Security and private pension systems, the marriage penalty in the federal personal income tax system, and the payment of alimony and child support by absent parents. She has published extensively on federal policy and employment issues, which were the focus of her research while on the faculty of the Graduate School of Industrial Administration at Carnegie Mellon University.

She received her Bachelor's Degree in Economics from the University of California at Berkeley in 1964 and her Doctorate in Economics from Stanford University in 1970. While attending Stanford, she was awarded a Woodrow Wilson Fellowship, an IBM Fellowship, and a Stanford-Wilson Dissertation Fellowship.

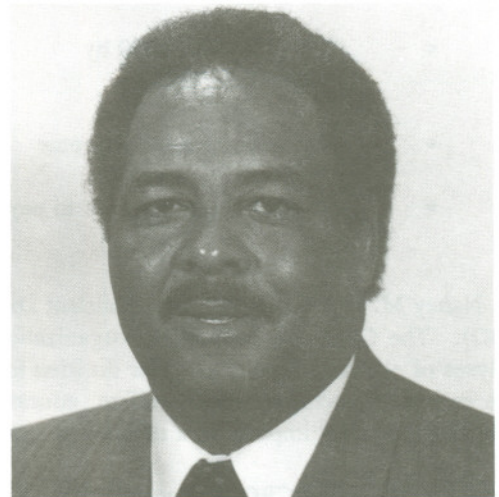
## *The President's Message*

## SUMMARY OF FEBRUARY LUNCHEON SPEAKER'S REMARKS

Congressman William Jefferson of Louisiana was our speaker at the February 3, 1994 Chapter luncheon meeting at the Touchdown Club. He discussed the accomplishments of the first session of the 103rd Congress and the outlook for the second session. The Congressman is a member of the Ways and Means Committee which has wide ranging responsibilities extending to tax, trade, welfare, pension, and other issues.

The economy was the principal focus of the first session. The Congressman views passage of the Budget Reconciliation Act after extensive debate as one of the session's major accomplishments. Its provisions directed towards reducing growth in the budget deficit and energizing the economy are working. However, the total deficit of \$4.3 trillion continues to require careful management. Passage of the North American Free Trade Agreement (NAFTA) was a second highlight of the session.

Congressman Jefferson expects the focus in the second session to shift to health care reform, welfare reform, and combatting crime. Recent polls show that the American

public considers crime the most serious issue facing the Nation. It is highly likely that Congress will respond to the public's concern. Both health care and welfare reform will be difficult areas to deal with because of the many diverse views that exist, but Congress should be able to enact legislation on these issues. It is also likely that Congress will legislate needed policies affecting the availability and financing of emergency disaster relief.

The Congressman expects "buy-out" legislation to pass early in the second session. Passage will avoid the necessity of lay offs to achieve the President's target of a reduction of 252,000 Federal employees.

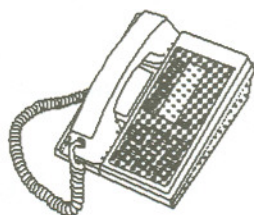
