

Additional details for each of these programs will be announced soon.














# Life after Cancellation

#### **Background**

Back in the 1950s, each appropriation was identified by a Treasury Account Symbol (TAS) that consisted of a two-digit Agency code, single-digit year, and four-digit major account or fund group code. With only a single digit as the year, the appropriation symbol would repeat every decade, causing cash, obligations, and authority from two separate appropriations to be reported together. In 1956, Congress addressed this problem with Public Law 84-798 which placed cash and unliquidated obligations from funds over three years old into a "merged" account. Treasury identified these with an "M" for the year indicator. Since agencies could restore large balances out of the merged accounts to pay for obligations, this practice reduced Congress' power of the purse, so they passed the "M Account" legislation (Public Law 101-510) in 1991. The new law required that the funds stay in place as expired for five years, then be permanently withdrawn.

However, that same year Congress also passed the CFO Act which led to agencies submitting trial balances by TAS. Now a new problem emerged: what to do about old assets and liabilities that were purchased or incurred in a fund that is about to be cancelled? While some long-lived capital assets are purchased in no-year funds that use an "X" for their year indicator, not all are. If the asset is still around, even if fully depreciated, it has to be reported on the books under some symbol. Many agencies routinely transferred their assets to a current symbol. In addition, when a fund is cancelled, the liabilities are supposed to be reported in account 296000. If the old symbol is gone, how can it be reported?

For the Government wide Treasury Account Symbol Adjusted Trial Balance System (GTAS), Treasury has resurrected the merged account as a "C Account". Unlike the "M Account", the new "C Account" will never contain cash, obligations, or budget authority. It will only be used to report assets and liabilities of cancelled appropriations. Originally use of the "C Account" was to be mandatory, but protests from agencies caused Treasury to make it optional. Agencies can report old assets, liabilities, and related transfers and expenses under the "C Account", or move them to an existing, valid symbol instead. GTAS will automatically create the C TAS but it will not populate it.



#### Implementation

The old "M Account" was handled automatically by Treasury without the agency having to record a transfer. However, the "C Account" requires agencies to record a transfer out of the old symbol using 573000 Financing Sources Transferred Out without Reimbursement and into the "C Account" using 572000 Financing Sources Transferred In without Reimbursement. Agencies will have to set up new funds in their system to use the "C Account" symbols and post entries to it as part of their annual close process. Agencies cannot simply remap the old funds to the new symbol (as they could have done for the "M Account") since the transfer has to be booked.

# **SGL Accounts**

Only a small fraction of SGL Accounts will be allowed in the "C Account". Probably the most important component in the "C Account" will be property, plant and equipment. If a building lasts 40 years and is paid for with annual appropriations (possibly over several years), it will spend most of its life in the "C Account". Even fully-depreciated equipment that is still in use will likely be reported there. Because agencies don't report balances in their cancelled appropriations, many have taken to transfer assets either to the current year or to a no-year fund using accounts 572000/573000 Financing Sources Transferred In/Out without Reimbursement. Some agencies have used revolving or working capital funds to handle the purchase of fixed assets for which the fund is reimbursed by the appropriated funds. These steps are no longer necessary. The assets allowed in the "C Account" are operating materials (151100 thru 151400) and fixed assets (171100 thru 189900). The only liability account allowed is 296000 Accounts Payable from Cancelled Appropriations. Potentially long-term liabilities such as 222500 Unfunded FECA Liability and 292000 Contingent Liabilities will have to be transferred to a current TAS.

Of course, the only equity account permitted is 331000 Cumulative Results of Operations, since this fund is, by definition, unfunded. Agencies can record transfers (using the aforementioned 572000 and 573000 accounts), depreciation (671000), remove canceled payable (680000 Future Funded Expenses), and dispose of assets (711000 Gains on Disposition of Assets – Other or 721000 Losses on Disposition of Assets – Other).

#### **Budgetary Accounts**

I could not find any details on budgetary accounts in the "C Account". Since GTAS includes trial balances for both proprietary and budgetary accounts, it is likely that Treasury will expect agencies to include the balances of 420100 Total Actual Resources – Collected, 420800 Adjustment to Total Resources – Disposition of Canceled Payables, and 435000 Canceled Authority, which were not reported in FACTS II.

#### Conclusion

Many agencies simply exclude cancelled funds' balances from their trial balances and financial statements. Since balances are not reported, there is little incentive for agencies to clean up these trial balances and set most account balances to zero. These agencies also have to transfer any balances they do want to report into an open fund. With the new "C Account" logic, agencies will need to maintain trial balances for their cancelled funds.


As we head into the new FY 2016 Chapter year, we are excited to communicate and support public services that other non-profits are providing throughout the Washington DC area.
