Meeting Minutes for January 8, 2008

Jerry Mitchell called the meeting to order at 11:35am. The officers in attendance (Deb Fraley, Deb Gillenwaters. Justin Hill. Vickie Frankie and Teresa Allen) and Bob Wells were present for the meeting to discuss the spring seminar and future speaking topics. A motion to approve the December meeting minutes and finance report was made and passed by voice count.

The officers discussed what topics would draw the most interest for the spring seminar and monthly meetings. The monthly meeting location was again brought forward. Panera Bread at St Louis and National is not an option; the room can not be reserved during the lunch hour. New possibilities could be meeting rooms at OTC or on the Drury campus.

CGFM Exam Update

In 2007, AGA undertook a psychometric review and update of the three CGFM Examinations. To ensure the examinations' content reflects the current industry practices, AGA conducted a full-scale Job Analysis Study of the role of the Certified Government Financial Manager. While the core of the examination content remained the same, the three examination content outlines updated. refreshed were streamlined. and The

weighting among the subcontent areas within each examination was adjusted, and the language of the content outlines was revised to provide additional depth and detail to support candidates preparing for the examinations.

The updated CGFM Examinations will be offered for the first time at the Intensive Review Course/CGFM Examinations event to take place before the Professional Development Conference in Atlanta on July 24-27, 2008. The updated examinations will be available in Prometric testing centers beginning on Aug. 15, 2008. CGFM Examinations taken prior to that date will follow the existing examinations content outline. Federal Reserve Cuts Rates as Expected and Markets Rally (for now)

The Fed decision to lower rates by a half point was the anticipated one and the markets in the US reacted with appreciation. As the day for the decision grew near, the conjecture swirled over whether the Fed would decide to reduce rates by only a quarter point or would shock the system with yet another three quarter point cut. This is not the week the markets wanted to be surprised and the half point cut

was judged appropriate. This cut plus the one announced last week brings the interest rates down to 3% and by all accounts the Fed is prepared to move them even lower if the economy is not responding. The next scheduled meeting of the Fed is March but nothing precludes the Fed from doing something early although most analysts doubt whether conditions will warrant such a move.

Analysis: The critique of the Fed at the moment is that these moves are starting to undermine its credibility in the financial world. This is a somewhat ironic development as it has been the financial world that has called most vociferously for the cuts. The notion is that it is the Fed's job to be the voice of reason and

that allows the investors to play to their own self interest. If the Fed is too accommodating to the markets and seems to be trying to please them alone, the Fed loses that veneer of expertise. Thus far Bernanke has managed to make the case for the Fed's moves but if there is much further response to what are interpreted as purely market pleas the impact of Fed actions could be diluted. -Chris Kuehl, MSCPA Business Intelligence Brief, Jan. 31, 2008
