Chapter Meeting Minutes Sept 17, 2008

Steve Gorcester, Executive Director of Washington State Transportation Improvement Board, explained the importance of Dashboards for monitoring performance. He demonstrated how the dashboard effectively showed the status of budgeted of projects, and performance measures, such

as the timing of payments and other transactional data. He also demonstrated the user-friendly data retrieval tools used in the website. The presentation was a very informative source of insight on how to present governmental accounting data in user friendly fashion in today's electronic world. Several members stayed after his presentations to discuss further how to implement such a system.

Chapter Executive Committee Minutes Sept 16, 2008

The Ozarks Chapter of AGA held a board meeting on September 16, 2008 in the Springfield-Greene Health department's first floor conference room.

The board members present were Deb Gillenwaters, Teresa Allen, Justin Hill, Jerry Mitchell and Linda Charles.

The items discussed were:

The CPA Day Seminar brochure was created by Deb Fraley and the Ozarks Fall Seminar flyer was created by Teresa Allen.

Deb Gillenwaters and Teresa Allen have checked the Internet connection at Cooper Tennis for the September 17 presentation on Dashboards. Steve Gorcester, Executive Director of the Washington State Transportation Improvement Board, will arrive in Springfield this evening. Mr. Gorcester will speak to Springfield-Greene County Health Administration, the Institute of Management Accountants, and the Ozarks Chapter of AGA members.

Review of articles 5 & 6 of the by-laws was tabled until next month's meeting, scheduled on October 21st.

Stephanie Teasley, the Ozarks Chapter Treasurer, has restructured the Chapter financial reports for members to read in the newsletter and on the website.

The fee for Paul Koehler to speak at the CPA seminar is \$2,500. Teresa Allen made a motion to send a retainer in the amount of \$500 to Paul Koehler. The motion was seconded by Justin Hill. A charity golf tournament will be held at Rivercut the day after the CPA Seminar. The proceeds from the tournament will be donated to Weller Elementary School as a match for Weller's math kit grant.

The speakers for the Ozarks Chapter's seminar on October 14th will be:

Mark Bailey, Social Security Administration, will speak about the Office of the Inspector General – one hour CPE. Michelle Holland, State of Missouri, will speak on the implementation and monitoring of Purchasing Cards – two hours CPE.

Ruth Shyrack, Jordan Valley Community Health, will speak about implementing a Code of Conduct – one hour CPE.

The Ozarks Chapter's Fall Seminar cost will be \$60 to members and \$80 to non-members. Snacks will be provided. Attendees can purchase beverages from vending machines.

A task force was formed to study sending two officers to the PD conference in June. The Hotels are covered. Linda Charles and Justin Hill will check on the cost of the conference. Jerry Mitchell also agreed to work with Linda and Justin to make a recommendation to the CEC and subsequently to the full membership.

A conference call on early career members will be held on either September 25th or 30th. Deb Gillenwaters will not be available on the 25th and has asked for others to participate in the call.

Justin Hill has notified the Tower Club that the Ozarks Chapter will be on a month-to- month basis for meetings. Meetings will resume at Tower Club in December 2008 and continue through March 2009.

Position Summary:

Under the direction of the Chief Financial Officer, assists in the direction and coordination of Accounting, financial reporting, and budgeting activities of the Springfield Public Schools.

Position Description:

- Process, monitor and provide accurate and timely financial information.
- Develop, recommend, interpret and implement policies and procedures affecting general accounting, budget and investment functions for the District.
- Supervise the accounts receivable/payable function, the budget function, the investment function and the payroll function for the District.
- Assist site/program administrators in their program planning, including organizational goal achievement, budgeting, facilities, equipment, supplies, utilization and statistical and financial reporting.
- Provide leadership in the development and the implementation of new financial information and reporting systems.
- Act as a liaison between assigned department personnel and other District staff and the public as appropriate.
- Develop and maintain short-term and long-term financial projections.
- Coordinate the annual audit to ensure that requested supporting documentation is provided accurately and timely.
- Ensure accurate and timely submission of Annual Secretary of the Board Report (ASBR).
- Advise all District administrators on financial management of their departments.
- Provide management, operational and accounting control systems. Establish a department organization structure that provides adequate direction through supervision. Carefully select, train, and supervise employees and provide opportunities for individual growth. Develop and maintain current position responsibilities for each person in the department.
- Supervise the department budget, salary increases, fee adjustments and reimbursement activities.

All duties and standards within this document will be performed in compliance with regulatory guidelines and applicable District, state and federal regulations and laws according to Springfield Public Schools policies and procedures.

Qualifications:

- Minimum of a Bachelor degree in accounting or finance. Advanced degree or professional certification as a Certified Public or Governmental Accountant is preferred.
- Four to five years of experience in a position of comparable responsibility. Government experience is helpful.
- Possess the ability to work with staff and communicate effectively at all levels within the District with a commitment to meet and facilitate the needs of the SPS community in a "customer-oriented" manner.

Oil Trades as Low as it has Been in Over a Year - Other Commodities Follow

The threat of imminent global recession is hammering away at commodity prices, providing a small silver lining to the current economic crisis. Oil prices fell by another \$5, taking them to the low 80s. There are suggestions that oil could well sink into the \$60 range again before the year is out. The bad news is that this collapse will take place because of the other economic concerns. Steel, copper, aluminum and other metals are also falling as the market assumes that demand is about dead.

There really is some good news in this. The central banks have been freed of inflation concerns for the moment and that gives them the flexibility to engage in the rate cutting moves they have started. At some point all this liquidity is going to come back to haunt the system; but for now, the banks are able to address the immediate issue without fear of stagflation. The commodity price hikes that had been threatening to shut down consumers and manufacturers have largely faded. Not that consumers are dancing in the streets as other concerns now preoccupy them, but at least they can fill their gas tanks without taking out a loan. -Chris Kuehl, The Business Intelligence Brief
