

The following are the latest governments to join a growing list of state and local governments and federal agencies that are producing four-page citizen-centric reports: **Guilford County (NC), City of**

Portsmouth (VA), the City and County of Denver (CO), Metro Government of Nashville and Davidson County (TN), the Treasury Franchise Fund (U.S. Department of the Treasury), the Idaho State Police, and the states of New York and Idaho.

AGA members believe that government accountability and transparency are essential to a healthy democracy and are committed to fulfilling our obligation to advance government accountability. This initiative is focused on compelling governments at all levels to improve how they present financial information to taxpayers, so that it is clear, accurate, up-to-date and easily accessible to all. In these tough economic times, it will take all our knowhow, resources and courage to steer our way through to the sustainable fiscal accountability taxpayers expect and deserve.

AGA offers a **Certificate of Excellence in Citizen-Centric Reporting** for governmental entities that prepare and distribute four-page reports that provide citizens with clear information on a government's financial condition, its performance in providing services, and challenges it faces in the future. To be eligible for the **Certificate of Excellence**, governments must incorporate into their report the program's high standards of content, visual appeal, readability, distribution and timeliness in reporting. Stimulus Projects Are Bright Spot For Construction Industry

The billions of dollars in stimulus funds being spent on facilities and highway construction projects is the lone bright spot in an otherwise gloomy outlook for the nation's construction industry this year, contractors say.

After a year of near-record layoffs, the construction industry is bracing for another tough year, according to a business forecast issued Wednesday by the Associated General Contractors of America. The forecast, which is based on survey responses from nearly 700 construction firms submitted in late December and early January, finds nearly nine in 10 contractors predicting continued hardships this year.

"Unfortunately for the industry and for our economy, this year's construction outlook is far from positive," said Stephen Sandherr, the association's CEO. "As long as the construction industry remains mired in its own depression, broader economic and employment growth will continue to lag."

Sixty-four percent of responding contractors expect demand for new manufacturing facilities will decline this year, while 71 percent expect demand for new retail, warehouse and lodging facilities will drop. Six in 10 firms say they're unsure whether they will be able to hire new staff or will need to make further cuts.

The Recovery Act, passed nearly a year ago, remains a bright spot. Thirty-one percent of contractors surveyed say they were awarded stimulus-funded projects. Of those, 46 percent say the stimulus helped them retain an average of 24 employees each; 15 percent say the stimulus helped them to add an average of 10 new employees per company; and 12 percent cite the stimulus as driving new equipment purchases.

Fifty-five percent of contractors believe work on public buildings will improve or remain stable in 2010, while more than 60 percent say the same about highway projects and water and sewer construction.

"The stimulus is finally beginning to have a measurable, but limited, impact on the construction industry," Sandherr said.

2011 White House Budget Proposal

If you check out the White House's budget webpage, you may be a bit confused. In large letters it states "A new era of responsibility - the 2011 budget." However, the subsequent budget calls for \$1.6 trillion in deficit spending next year, up from \$1.4 trillion in 2009.

The details of the budget are a bit ominous. It projects unemployment to remain at 10 percent this year, decrease to 9.2 percent in 2011 and further decrease to 8.2 percent in 2012. Furthermore, significant budget deficits are outlined for the foreseeable future.

The budget includes both tax cuts to certain groups and tax increases to certain groups. However, to deal with the bulging deficits, the tax increases greatly outweigh the tax cuts. The tax increases on upper income families alone is approximately \$1 trillion over a ten year period. Here are some of the detailed tax proposals in the budget:

Bush-era tax cuts - Most of the tax cuts implemented under the Bush administration are set to expire at the end of this year. President Obama's proposal is to extend the tax cuts to those earning under \$250,000 (\$200,000 if single). For those earning over these amounts, he proposes to let the tax cuts expire. The most significant impact of these expiring tax cuts would be an increase in the 33 and 35 percent individual tax brackets. These would increase to 36 percent and 39.6 percent, respectively.

Limiting tax deductions - Another tax increase that will impact higher income families is to limit the benefit of itemized deductions, such as mortgage interest, state taxes and charitable contributions. This would reduce the effectiveness of an itemized deduction by about 25 percent.

Increase the capital gains rate - For those earning over \$250,000, Obama proposes an increase in the capital gains rate from 15 to 20 percent.

Bank tax - A tax on banks of \$90 billion over the next ten years is proposed. This tax is to pay primarily for the direct bailouts of General Motors and Chrysler, not to mention the indirect bailouts, i.e., cash for clunkers and deductibility of automobile sales tax.

Oil, gas, and coal tax - These companies will be exempted from a manufacturing tax break available to other comparable companies. This will raise taxes on this group nearly \$40 billion over the next decade.

Investment managers - The budget proposes to change the way private equity and other money managers are taxed. Those folks will see an increase of \$24 billion in taxes over the next decade.

Make work pay - Obama proposes to extend this tax break for one more year. Individuals will receive \$400 and couples filing jointly \$800 on their tax returns.

Purchase of capital assets - Obama has proposed to extend through 2010 a benefit to small businesses that purchase equipment.

Incentives for Small Businesses - It would give companies a \$5,000 tax credit for each new worker they add in 2010. It would also extend a provision in the stimulus bill to allow small businesses to write off up to \$250,000 of qualified investments.
