"The accounting scarcity shows little sign of abating. More accountants are retiring without an adequate pipeline of entrants to the profession. Many prospective accountants are deterred by entry-level salaries lower than those for tech and investment-banking positions, as well as by the 150 college credit hours required to become a certified public accountant, which essentially amounts to a fifth year of college. An industry working group convened by the American Institute of Certified Public Accountants, a professional association, is expected to propose overhauls to state licensing rules later this year."
