CGFM You Pass We Pay Program (YPWPP)

The You Pass We Pay Program (YPWPP) is a great way to assist Chapter members meet their goal of obtaining the CGFM. There are three basic criteria to the YPWPP:

- Only NM Chapter members are eligible for this program since it is unique to our Chapter.
- Participants are given six (6) months to take and pass all three examinations. This clock starts "ticking" when an agreed upon date is reached by the CGFM Coordinator and the participant. We will send out a letter welcoming you to this program, which will have the start date. What we like to let participants know is that they should have already applied for the certification and have received a letter/email from the AGA National Office acknowledging their CGFM application approval. This way no time will be wasted applying for the CGFM and you can concentrate on studying for the exams.
- Upon successful approval, the participants will need to provide us a copy of the letter from AGA National stating they have passed. This will allow us to verify that the exams were completed within the six-month time-period. Additionally, we will ask for proof of payment and a statement saying that the applicant has received no further financial assistance for this process (i.e. having the employer paying for the exams).

To maintain the CGFM certification in active status, individuals must continue to abide by AGA's Code of Ethics, renew CGFM annually and earn 80 continuing professional education (CPE) hours every two years.
