- 1. The rates are as follows:
 - Members-only rates: \$30 per quiz or \$109 for four quizzes.
 - Non-member rates: \$56 per quiz or \$204 for four quizzes. Non-member rates do not include a copy of the *Journal*.
- 2. Read the quarterly *Journal of Government Financial Management*. Plan on spending about three hours to read the applicable information and take the quiz.
