**New Beginnings**

Hello and welcome to a "new beginning" for the Washington DC Chapter of AGA! The Republicans and Democrats are both touting new beginnings for our Federal government. National AGA has embarked on two new beginnings: we inaugurated the 2000/2001 program year at the Professional Development Conference in San Francisco in July and we will kick off the second semicentennial (fifty-year period) at our luncheon meeting on September 14th (more about that later). The Washington Chapter also has a new beginning for the 2000/2001 program year, and I guess that makes me the chief New Beginner (hence the picture above, which I will use only once in this issue).

But, you ask yourself, aren't all beginnings new? In my way of thinking, a true beginning is something done for the first time, while a new beginning is beginning again, a rebirth, an opportunity to do the same thing again but, hopefully, better or with a fresh outlook.

The Federal government has a new beginning every four years. AGA and the Washington DC Chapter have one every year—new officers, new directors, new events, new speakers, new members, and new programs. It is an opportunity to renew our commitment to you to have a professional organization that is active, alive, aggressive, and accountable (and I didn't actually plan that as

an alliterative!). You, too, have a new beginning each year when you renew your membership in AGA – an opportunity to renew your commitments to attend monthly luncheon meetings and educational events, participate in AGA committees and other activities, network with your peers in the Federal financial management community, and enjoy the companionship of people with similar professional interests.

**The Bottom Line**

The real bottom line for you, me, the Washington DC Chapter, and all of AGA, is the state of government financial management. For those of you in, or involved with, the Federal government, I hope you caught the lead article in the Summer 2000 edition of JFMIP News, titled "2000 Federal Financial Management Report" – the bottom line is looking better! The article highlights the recent report on financial management issued by OMB and the CFO Council. Since the passage of the CFO Act in 1990, all areas of emphasis are showing definite progress:

Accountability to the Public – the twenty-four largest departments and agencies in the Federal government now issue financial statements annually and the government has issued its third government-wide financial statement.

Reliable Financial Systems – more and more agencies are meeting FFMIA, Federal accounting standards, and SGL requirements.

Better Financial Management – major advancements are noted in the areas of e-commerce, e-government, grant applications, and debt and credit management.

Building Professionalism – many initiatives are focusing on building a quality financial management workforce.

At our planning meeting in June, the new officers and directors and I discussed what programs, events, educational sessions, newsletter articles, community service activities, research activities, speakers, etc., we'd like to feature during the coming year. We adopted an overall Chapter theme of "Advancing Government Accountability Through Partnerships." We have many partners in chapter and association activities: other professional organizations like AABPA, AICPA, ASMC, GFOA, IIA; and corporate partners like the consulting firms who advertise in this newsletter, help sponsor educational events, and support us in so many ways. Enhancing these partnerships will strengthen our Chapter and improve our professional networks.

We also outlined what we hope you will find is an exciting agenda to meet our goals of serving members' organizational needs, professional needs, educational needs, and community service expectations:

- Continue monthly luncheon meetings at the Grand Hyatt Hotel at Metro Center.
- Continue to feature speakers who are outstanding leaders in the Government financial management community, people like Josh Gotbaum (OMB), Ned Powell (VA), Bob Hale (Air Force), and Morgan Kinghorn (PricewaterhouseCoopers).
- Continue CPE sessions following the monthly luncheons (except September).
- Hold three multi-day educational conferences.
- Participate in community service activities, including Toys for Tots, Project Harvest, VITA (Volunteer Income Tax Assistance) Program, American Heart Association, Central Union Mission, Small Business Seminar, and others.
- Continue to publish research articles in this newsletter that focus on the technical how-to's of governmental accounting and auditing.
- In my messages to you throughout the coming year, I will continue to report on Chapter business and the activities of the Executive Committee. Let me know if you have any items of interest to the membership that you would like me to address.

### **50th Anniversary Celebration**

Over the past year, AGA has sponsored many activities to celebrate its fifty years of providing professional activities throughout the world for those involved in government finan-

cial management at all levels. The culmination of this effort is the Grand Finale Celebration, a three-day event that gets under way on Thursday, September 14th, at our Chapter Luncheon Meeting. This 50th Anniversary Luncheon will celebrate AGA's official organizational meeting held on September 14, 1950, when the founding fathers adopted bylaws and elected officers. National President Bill Broadus will be our first luncheon speaker and many National Executive Committee members, Past National Presidents, and other dignitaries will be in attendance. This promises to be a special event – don't miss it!

On Friday, September 15th, the 50th Anniversary Seminar will be held in the Coolidge Auditorium in the Jefferson Building at the Library of Congress. The theme for this all-day symposium is "The Future of Government Financial Management" and it promises to be an exciting educational event.

On Saturday, September 16th, the 50th Anniversary Gala will be held at the JW Marriott Hotel on Pennsylvania Avenue. This black-tie-optional extravaganza will include a reception, dinner, and dancing to the big band music of Doc Scantlin & His Imperial Palms Orchestra. The gala will close the door on AGA's 50th Anniversary Celebration and will undoubtedly be a fitting ending to a wonderful year as well as a rousing new beginning for the next semicentennial. ### **Final Thoughts**

As we begin the 2000/2001 program year and close the door on the 50th Anniversary Celebration, the original objectives of the organization are still our guiding light for the next fifty years, as reflected in our mission statement:

"AGA serves professionals in the government financial management community by providing quality education, fostering professional development and certification, and supporting standards and research to advance government accountability."

How we carry out this mission is the most important focus for the Chapter. In his inaugural address at the PDC, newly-elected National President Bill Broadus summed it up nicely. He said, "The organization must first serve the needs of members. Second, the organization must serve its members' organizational needs. Third, the organization must serve its members' professions. And fourth, the organization must be involved in community services."

I take this as my personal statement of stewardship for my term as your Chapter President. As chief steward, my goals are to do no harm and to leave the chapter better than I found it. I plan to have fun doing that and hope you will join me.

## Capping Fifty Years of Advancing Government Accountability: The Grand Finale Celebration.....

AGA's 50<sup>th</sup> Anniversary Celebration will come to a spectacular grand finale on Thursday, Friday, and Saturday, September 14, 15, and 16 in Washington, DC, the birthplace of AGA. The 50<sup>th</sup> Anniversary Committee and the Washington DC Chapter invite you to attend three outstanding special events, including eight hours of continuing professional education. All three events are conveniently located near Metro stops for easy commuting to and from the airport, home, or office.

The grand finale events get under way on Thursday, September 14 at the Washington DC Chapter's 50<sup>th</sup> Anniversary Luncheon meeting at the Grand Hyatt Hotel. This luncheon will celebrate the Association's official organizational meeting on September 14, 1950, when the founding fathers adopted by-laws and elected officers. From that time until July 1, 1956, the Washington DC Chapter served as both the national organization and the local chapter. The 50<sup>th</sup> Anniversary luncheon is \$25 for AGA members and \$35 for nonmembers.

The 50<sup>th</sup> Anniversary Symposium will be held from 8:30 am to 5:00 pm, Friday, September 15 in the Coolidge Auditorium in the Jefferson Building at the Library of Congress. The theme for the Symposium is "The Future of Government Financial Management," and promises to be one of the best AGA education events ever. As always, participants can expect the best from the symposium's speakers. The opening remarks will be by David M. Walker, Comptroller General of the United States. In addition to Mr. Walker, there are panels on the fu-

ture of governmental accounting (panelists from AICPA, FASAB, GASB), auditing (panelists from AICPA, GAO, IIA), budgeting (panelists from CBO, NASBO, OMB), and technology in government financial management (panelists from government & industry). These panels are certain to appeal to all government accountability professionals. The symposium is \$99 for AGA members and \$149 for nonmembers.

The 50<sup>th</sup> Anniversary Gala will be held Saturday, September 16 at the JW Marriott Hotel on Pennsylvania Avenue. This black tie optional evening Gala promises to be a night you will not want to miss—reception, recognition dinner, and music to dance the night away. Doc Scantlin and His Imperial Palms Orchestra will transform the JW Marriott ballroom into a time machine. You will swear you have stepped into a scene from a grand old MGM musical as the band swings through the big-band songbook. A three-time winner of the Washington Area Music Association Best Big Band Award, the orchestra has performed throughout the U.S. and Europe, and entertains at the world famous Rainbow Room atop Rockefeller Center in New York. Gala tickets are \$50 each before August 31 and \$60 each thereafter.

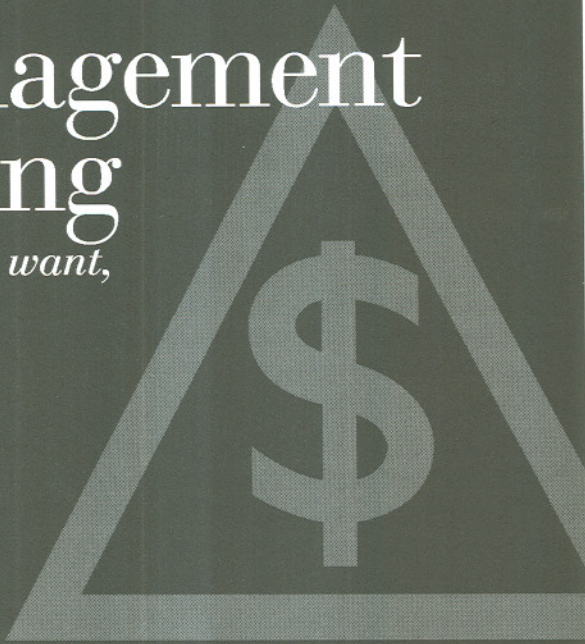

**Inside the Black Box: Accounting for Capital Leases in an Appropriated Fund .....**

**W**hat is a capital lease? A lease provides an asset in exchange for a stream of cash over a number of months or years. If the terms of the lease substantially transfer the risks and benefits of ownership to the lessee (as described in SFAS No. 5), then it is a capital lease, and the accounting should be the same as if the agency had purchased the asset and took out a loan to fund it. Let us say an agency signs a lease which requires payments of \$1,000 a year for 3 years out of an appropriated fund. If the lease is an operating lease (i.e., it is not capital), then the posting for \$1,000 each year would be:

Debit	
6100	Operating Expense
4610	Allotments - Realized Resources
3100	Unexpended Appropriations
Credit	
1010	Fund Balance with Treasury
4902	Expended Authority - Paid
5700	Expended Appropriations Used

If the lease is capital, though, OMB Circular A-11 requires an immediate expenditure for the asset's cost. This is calculated as the present value of the future cash payments. If the current discount rate is 6%, then the first payment, made immediately on signing the lease, is worth \$1,000; the second payment, made a year from now, is worth  $\$1,000 / 1.06 = \$943$ ; and the last payment, made 2 years from now, is worth  $\$1,000 / (1.06 * 1.06) = \$890$ ; for a total of \$2,833. The entry made to recognize the capital lease would be posted as follows for \$2,833:

The entry to record the lease payment is split between an expenditure against 6330 Other Interest Expense and liquidating the 2940 Capital Lease Liability. Since the first payment is made

immediately, there is no interest and the whole \$1,000 is applied against the liability with the following posting:

The interest amount on the second payment is  $.06 * (2833 - 1000) = \$110$ , so the reduction in the liability is  $\$1,000 - 110 = \$890$  (note that the sequence of values is reversed from the calculation of the present value of the payments above). The last payment has interest of  $.06 * (2833 - 1000 - 890) = \$57$ , and the liability reduction is \$943. The posting to 6330 is recorded as follows:

In a previous *Inside the Black Box* (November, 1998), I described how a fixed asset purchase is a funded item, while transfers and usage/depreciation of fixed assets are not. This distinction is important when preparing the Statement of Financing, as funded items that are not expenses are reported on line 2, while unfunded expenses are reported on line 3. The capital lease is treated like any other acquisition, with debits to 1810 reported on line 2c, and the depreciation reported on line 3a. Account 2940 Capital Lease Liability is not reported on the statement at all; it is a covered (funded) liability, just like 2110 Accounts Payable.
