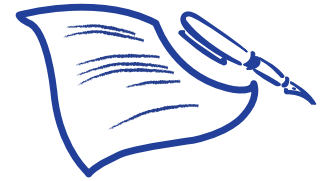

Ms. Robinson is currently the CFO of NASA.

Lastly, I also thank those that participated in providing gifts and or donations for children and families in need, especially during this time of the year. Your gracious contributions during our luncheon will support many families and hopefully bring a smile to a child's face.

Update on Winter and Spring CGFM Training Classes

The DC Chapter will once again be offering free classes for all three modules of the CGFM exam. The classes will be held on the following dates in Washington D.C. (metro accessible):

- January 31, Module 1
- February 1 and 2, Module 3
- February 7-February 9, Module 2

Please be on the lookout for the training registration which will open in early January. There will be an e-mail blast sent out on the AGA listserv in early January announcing the opening of the registration. Please note that this is very popular and the classes fill up very quickly.

The registration acceptance will be first come, first serve.

New CGFM Scholarship Program

In an effort to provide new programs and opportunities to help our members achieve their CGFM certification goals, the DC Chapter is proud to announce that we will be providing a CGFM Scholarship Program for the first time this year. The 1st opportunity is occurring during this month of December in which recipients of the scholarship will be reimbursed the full purchase cost of their exams, once they have passed all three required exams. The 2nd upcoming opportunity will be an essay contest (on subject of why do you want to be a CGFM and how will it benefit you) in which the winners will receive free training study guides. There will be further information regarding this essay contest sent out in January-please be on the lookout for this.

CGFM Chapter Incentive \$20 Rebate for Applicants

Have you been waiting for yet another great reason to apply for the AGA CGFM Program? Well, through December 31st, the AGA is giving a rebate of \$20 for CGFM applications received with the assistance of AGA chapters. Here is how it works - In order to receive a \$20 rebate:

- Complete a CGFM application (application form, \$85 application fee and copy of the transcript) it must be received by AGA Office of Professional Certification by December 31, 2011.
- The CGFM application form must have the promotional phrase: "CGFM chapter promotion – DC Chapter" (or whichever Chapter you belong to) written at the bottom of the form. If the application is submitted online, the applicant must put this phrase in the last question: "How did you learn about the CGFM Program?"

Important notes:

- > A full application fee of \$85 must be paid at the time of application. The \$20 check will be sent to the applicant by mail in January.

- > The applicant must put the words “**CGFM chapter promotion**” AND the name of your chapter on the application form in order to receive the rebate.
- > It is preferable that the applications are submitted by the applicants themselves and not by the chapter. The applicant does not have to be a chapter member in order to receive the rebate.

Interested in the CGFM certification? Sign up for AGA's special [Intensive Review Course](#) and take the CGFM Examinations after the 10th Annual National Leadership Conference (NLC). Don't miss this opportunity to earn your CGFM. The Intensive Review Course will take place from 8:30 a.m. – 5:30 p.m. on Monday, Feb. 27, and Tuesday, Feb. 28, 2012. The CGFM Examinations will be offered by appointment only on February 29 – March 2, 2012. The cost of the course is only \$279 for qualified participants, and offers 18 CPE hours. And, as a special bonus: the CGFM examinations are offered at no cost to course attendees. The cost of this course is not included in the NLC registration fee. Interview with Ana Chaletzky, CGFM, and AGADC Member

Leon Fleischer: Why did you feel it was important to get your CGFM?

Ana Chaletzky: I have been involved in private, public and non-profit accounting for years and recently started at the Library of Congress. I thought it was important for me to learn about governmental accounting areas which the CGFM courses and exams concentrated on. I also felt it would help me with advancing in my profession and adding value to my government career.

Leon Fleischer: How long have you been an AGA member?

Ana Chaletzky: I joined AGA in February 2010 and signed up because I wanted to participate in the free CGFM training. Unfortunately, it filled out so quickly that I had to wait until the winter training.

Leon Fleischer: Have you taken other AGA training classes in the past?

Ana Chaletzky: Yes, I have taken several audio conferences such as internal controls and challenges in auditing profession.

Leon Fleischer: How did you hear about the AGA CGFM study guide class?

Ana Chaletzky: I heard about AGA and CGFM first through a co-worker and then through my supervisor. After I became an AGA member, I subscribed to the mailing list and received the e-mails regarding free training for CGFM offered by the chapter and I signed up.

Leon Fleischer: Was the location of the class convenient?

Ana Chaletzky: Yes, the location was close to metro/public transportation and there were many choices for lunch places.

Leon Fleischer: What did you think about the volunteer instructors?

Ana Chaletzky: The instructor, John Herko, did a great job. He covered a lot of material in a short time. He used real life examples. I also was able to network in the class.

Why Earn the CGFM? (cont'd)

Leon Fleischer: *Which part was the most difficult for you?*

Ana Chaletzky: I found the Governmental Accounting, Financial Reporting and Budgeting section (part II) to be the most difficult. Part II contained a lot of information on state governmental accounting-and that was interesting but hard-I was not familiar with modified accrual basis of accounting. Also, the questions written for Part III were complicated but Part II was the hardest. I took the Part I exam first because that was the easiest and it gave me confidence to then take the other two parts. This worked out well for me. I was able to pass all three parts on the first time.

Leon Fleischer: *Would you recommend using the study guide class for other potential CGFM students?*

Ana Chaletzky: Yes, I definitely recommend using the study guide class. For me personally, I retained a lot from the class. The instructor pointed out certain areas for focus on. I also recommend taking the exams right after the training while the information is still fresh from the training. I took the three exams shortly after the training and passed all three parts.

Leon Fleischer: *What could we do to improve the CGFM course?*

Ana Chaletzky: I am also studying now for the CPA exam using Becker Professional Education -and they provide DVDs, simulation questions which are timed, flash cards, various methods of studying. Possibly, the CGFM course could expand and try in addition to the current method additional media for students who may learn better using different or various approaches.

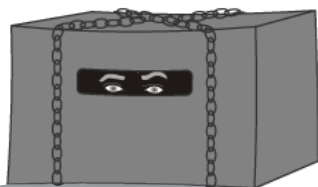

Inside the Black Box

A Look at the New Statement of Budgetary Resources – Sections 3 & 4

Introduction

Treasury has now released the format and mappings for the new Statement of Budgetary Resources (SBR). Looking at the bottom sections, the new SBR is pretty much the same as the old one.

Comparison

The chart below compares the main lines of sections 3 and 4 between the two formats, leaving off some header and total lines. The first difference is that the new line numbers are four digits and not sequential. They only somewhat map to similar lines on the SF-133. For example, line 3016 contains adjustments to both unpaid obligations and uncollected customer payments, whereas on the SF-133 the two are reported separately on lines 3001 and 3011. The second difference is that the new SBR tracks activity that serves to adjust beginning balances. The new lines 4175, 4179 and 4180 don't cleanly map to any lines on the old SBR.

For Section 3, it may be easier to understand the lines if viewed as a matrix rather than the linear format used in the report:

It is important to note that the activity reported as adjustments to beginning balance on line 3016 (and included in the total on line 3021) should also be reported in the ending balance on line 3090 or 3091 (as appropriate), though excluded from the activity lines 3032 through 3082. Also, line 3032 includes all obligation and expenditure activity except recoveries but including disbursements, so to map this to unpaid obligations, the disbursement activity is reported on line 3040 and deducted from the balance in 3032.

Section 4 of the new SBR includes the outlay calculation from the old SBR (lines 4176, 4177, 4190, 4200 and 4210), and intertwines it with a calculation of net budgetary authority (lines 4175, 4177, 4178, 4179, and 4180). The only line these two calculations have in common is 4177 Actual offsetting collections.

Conclusion

The new SBR format for sections three and four is similar to the old. The main differences are new lines for adjustments to beginning balances in section three, and calculation of budget authority in section four. Setting up the new report should not take much effort.
