### **News from National/NCC Rep**

Hello, everyone!

Now that our 2020-2021 program year is underway, I wanted to give you an update on National's new Awards for Chapter Excellence (ACE) program. As a part of the recent restructuring at the National level and the creation of the National Council of Chapters, it was decided to revamp how the National office and the chapters measure chapter growth, successes and accomplishments.

The old Chapter Recognition Program, in which chapters earned credits for various activities, has been replaced. The new ACE program helps chapters focus on meeting the needs of their members by setting measurable goals involving membership, education, certification, communication, etc. Chapters earn points toward an ACE award by meeting or exceeding these chapter goals.

A chapter has 9 requirements to complete before it is eligible for an ACE award. Some of those requirements include electing chapter officers, submitting annual chapter plans to the National office, filing the necessary forms with the IRS and state offices and engaging in an annual review of the chapter's finances. The National office has provided a timeline for a few of those requirements and offer bonus points for items submitted early.

Our chapter officers list and annual strategic plans were submitted to the National office before the corresponding deadlines. As a result, we earned 200 bonus points toward an ACE award. Meeting our CEC membership goal has earned us an additional 500 points. Currently, we have 700 total ACE award points, which puts us in the range for a Bronze award. See the 4 award levels below.

Platinum: 4,400 - 5,500 points Gold: 3,000 - 4,399 points Silver: 2,000 - 2,999 points Bronze: 100 - 1,999 points


#### **Random Financial Fact:**

### Why did you choose the CGFM?

#### Q: What prompted you to begin the process of obtaining your CGFM?

A: I came from a cost accounting position in a manufacturing environment. Coming into Government Finance was different in so many ways. I did not even know enough to ask the right questions. I knew I needed help and my old college adviser suggested the CGFM certification.

### Q: How has it helped your confidence?

A: The CGFM program starts with the basics and each new topic just builds on top of that. That helped me to understand "the why" for what I was doing. With each topic I learned and each test I passed, my confidence in the ability to do my job increased.

#### Q: How do you feel it has helped you in performing your job duties?

A: When you get your certification and you use the knowledge you have gained in your real-life work situations, you feel more assured that you are doing the right thing.

# Q: How has networking with other CGFM holders helped you?

A: As a "feel good" benefit, it brings you closer to your colleagues all over the area. The networking opportunities for CGFM holders can also help you



in gaining the information to better perform your job. You may not know everything, but the CGFM group is always willing to help each other out. They are a very supportive group, and everyone is happy to help.

#### Q: What did you find helpful in studying for the CGFM Certification?

A: The most important hint for me - Study buddies. Having a study buddy helps to hold us accountable and to encourage one another. Although we may not have been in the same town, we studied together. Shout out to Kat and Greg! We questioned each other, we helped each other understand things that one of us grasped and the other did not. We each had our own experiences and brought the knowledge we needed to help one another understand. They keep you on track, they encourage you, and will always celebrate with you when you all achieve your goals.

# Q: What would you suggest to candidates to help them pass the exams?

A: I tried, in every way I could, to associate what I was learning

with real life situations in my career or past jobs. This helped me remember what I did and why. Also, accountability with my study buddies was a big part of my success.

### Q: What resources did you use to help prepare?

A: The study guides explained everything. This helped me to think of what "could" be asked and I prepared for those possible questions. Again, my study buddies always pushed me to study, even when I did not want to.

Q: Did you know that Ozarks Chapter will reimburse you for the application and exams once all exams have been passed if your employer has not paid for them?

A: I did know this!

#### Q: How long did it take you from when you started the application process to complete the certification process?

A: It was about 18 months all together. From passing the first exam to passing the last exam it was approximately 9 months.

### **GASB UPDATES**

### GASB Adds Resources to Emergency Toolbox Addressing Issues Arising from COVID-19 Pandemic

GASB recently issued Technical Bulletin 2020-1, Accounting and Financial Reporting Issues Related to the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) and Coronavirus Diseases which raised several topics that were not covered in the specific Bulletin. GASB has added the following issues to the Emergency Toolbox in regards to those issues. Please visit the GASB Website for more information.

The topics covered are:

- Disclosures related to outflows of resources incurred in response to COVID-19
- Donated inventory
- Nonexchange financial guarantee disclosures
- Subsequent contravention of eligibility requirements
- Classification of transactions not specifically addressed in Category A or Category B authoritative literature as either operating or nonoperating revenues and expenses
- Extension of property tax due dates
- Subsequent events disclosures for legislation enacted after the end of the reporting period.



### GASB Seeks Participants for Revenue and Expense Recognition Field Test

The GASB is requesting feedback from preparers of governmental financial statements on these items:

- Potential implementation difficulties
- The perceived costs associated with the initial and ongoing implementation of the proposed standards
- Whether any of the proposed standards are unclear
