## **IRS Increases Mileage Rates through Dec. 31, 2008**

WASHINGTON — The Internal Revenue Service announced an increase in the optional standard mileage rates for the final six months of 2008. Taxpayers may use the optional standard rates to calculate the deductible costs of operating an automobile for business, charitable, medical or moving purposes. The rate will increase to 58.5 cents a mile for all business miles driven from July 1, 2008, through Dec. 31, 2008. This is an increase of eight (8) cents from the 50.5 cent rate in effect for the first six months of 2008, as set forth in <u>Rev. Proc. 2007-70</u>.

In recognition of recent gasoline price increases, the IRS made this special adjustment for the final months of 2008. The IRS normally updates the mileage rates once a year in the fall for the next calendar year.

"Rising gas prices are having a major impact on individual Americans. Given the increase in prices, the IRS is adjusting the standard mileage rates to better reflect the real cost of operating an automobile," said IRS Commissioner Doug Shulman. "We want the reimbursement rate to be fair to taxpayers."

While gasoline is a significant factor in the mileage figure, other items enter into the calculation of mileage rates, such as depreciation and insurance and other fixed and variable costs. The optional business standard mileage rate is used to compute the deductible costs of operating an automobile for business use in lieu of tracking actual costs. This rate is also used as a benchmark by the federal government and many businesses to reimburse their employees for mileage. The new six-month rate for computing deductible medical or moving expenses will also increase by eight (8) cents to 27 cents a mile, up from 19 cents for the first six months of 2008. The rate for providing services for charitable organizations is set by statute, not the IRS, and remains at 14 cents a mile. The new rates are contained in <u>Announcement 2008-63</u> on the optional standard mileage rates.

Taxpayers always have the option of calculating the actual costs of using their vehicle rather than using the standard mileage rates.

### Proposal to Redefine "Retired" Members, CGFMs on NBD Agenda

At the July 27 National Board of Directors (NBD) meeting, to be held at the 2008 Professional Development Conference in Atlanta, GA, one of the items on the agenda will be a proposal to revise the definition of the Retired member category in the AGA National Bylaws. This action requires a formal vote of the National Board of Directors. This article outlines the background and rationale for the proposed change.

The current definition of a Retired member is "individuals who have retired from and are no longer substantially working in the government financial management community" (Article IV Membership Section 6). The same definition has been used for CGFM retired status. The proposed new definition is "individuals who have permanently retired from and are not working in the field of financial management."

### AICPA to Launch Certified in Financial Forensics Credential

At its May meeting, the AICPA governing Council approved a new credential, Certified in Financial Forensics, in response to the marketplace's rising need for forensic accounting services. This credential will be the Institute's fourth, following the Personal Financial Specialist, Accredited in Business Valuation and Certified Information Technology Professional.

The demand for forensic accounting services is growing and the trend is expected to continue as businesses increasingly seek out experts to help them with a broad range of issues, such as economic damages, family law, fraud investigations and litigation. The Certified in Financial Forensics credential combines specialized forensic accounting knowledge and expertise with everything that makes CPAs among the most trusted business advisers. Moreover, it will debut at a time of popularity for forensic accounting as a career choice. The CFF will capitalize on a discipline with which the CPA is naturally associated and help distinguish credential holders as forensic experts.

Institute research revealed the increasing demand for forensic

accounting services is expected to continue for the next five years . Following are the requirements to qualify for the credential:

- The individual must hold a CPA license.
- Have a minimum of 5 years of experience in the general practice of accounting.
- Have a minimum of 1,000 hours of relevant forensic accounting experience.
- At least 75 hours of forensic accounting continuing education.

During the first three years following the launch of the credential, applicants will be able to qualify for the credential based on experience and education; they also will get credit towards qualification for holding other forensic accounting related credentials. It is anticipated that an exam will be instituted and become one of the qualification criteria beginning in year four.
