Dr. Rod Oglesby is a long time resident of southwest Missouri. An accomplished author he has published several articles in Activity Based Costing, Ethical Issues and Moral Reasoning, is currently researching the Ethics of Tax evasion. He has led numerous regional seminars, is a licensed CPA sitting on the MSCPA Ethics Committee and serves as lead Consultant with Mentor Group, LLC. Additionally, Dr. Oglesby is Editor of the Business Research Yearbook published by the International Academy of Business Disciplines and serves on the Editorial Board of the Journal of International Business Disciplines.
