AGA/WSCPA Government Accounting and Auditing Conference

The AGA Seattle Chapter co-sponsored the 2015 Government Accounting and Auditing Conference with the Washington Society of Certified Public Accountants. The annual conference was held in Tacoma, Washington at the Tacoma Convention Center on April 20 and 21, with

satellite locations included via webcast and in Everett and Spokane, Washington.

Approximately 200 attendees from across the state participated in the conference.

AGA Seattle board members Pat Bohan and Mary Ann Hardy served as conference cochairs, while AGA Seattle President Ken Smith and board member John Kurpierz participated in a panel discussion session at the conference entitled "Three Languages of Governmental Accounting." Other AGA Seattle Chapter board members attending the conference included President-Elect Diane Makaeli, Karyn Angulo, Sam Lord, and Tim Dobler. The conference agenda

included a wide variety of accounting and auditing topics ranging from updates to the Office of Management and Budget's new Omni Circular on federal grants to what government accountability professionals need know about cybersecurity. Bill Miller, the national President of the Association of Government Accountants, gave a keynote presentation on career development in the accountability profession entitled "You are Your Own Destiny" and also participated in the expert panel discussion of the "Three Languages of Governmental Accounting."

Following the conference, AGA board members Diane Makaeli, Pat Bohan, and Mary Ann Hardy arranged for a presentation to University of Washington-Tacoma accounting students made by Government Accountability Office Assistant Director Eric Holbrook. Mr. Holbrook, who was also a presenter at the conference, spoke to the accounting students on the topic of "Standards for Internal Control in the Federal Government." At the conclusion of Mr. Holbrook's presentation, he and the AGA board members fielded questions from the accounting students on career opportunities in accounting and auditing in the government sector.

Meet Your Board Members Ms Pat L Bohan CPA CGFM CGMA

Pat is a Senior Analyst at the Government Accountability Office (GAO) in Seattle, WA. Pat started her government career with the Air Force Audit Agency on March 3, 1986

in Mountain Home, Idaho. She was hired by the 'General Accounting Office,' the name by which GAO was formerly known, and assigned to the Chicago Regional Office, specifically, its Minneapolis-St. Paul (Twin Cities) office located on historic Ft. Snelling on January 4, 1987. As an Evaluator at GAO in Minnesota, she audited federal programs, such as the Department of Agriculture. When GAO announced that the Twin Cities office would close, Pat transferred to GAO Headquarters in Washington, D.C. in 1990.



In GAO HQ, Pat worked in the Accounting & Financial

Management Division and became a Financial Auditor. She was part of GAO teams that performed financial audits of the Army, including the Army Corps of Engineers, and the Department of the Navy, and performed various financial-related audits of specific defense financial statement line-items, such as the liabilities to decommission nuclear-powered naval vessels.

In October 1992, as a Senior Financial Auditor, Pat transferred to the Seattle GAO Office and continued to perform financial-related defense audits until she became a member of the GAO team performing the financial audit of the Internal Revenue Service. As part of the GAO Financial Team, she performed IRS financial statement audits until 2000, when she was asked to create a Defense Analyst Team in Seattle. She changed her title to a Senior GAO Analyst for Department of Defense programs and continues to be a member of GAO's Defense Capabilities & Management Team to this day.

When Pat transferred to Seattle, she became a Washington State Certified Public

The meeting was held the 27th through 29th of March in Detroit. Scholars of Government Accounting from all over the country were there to present papers, listen to speakers, and generally familiarize themselves with the most advanced and exciting government accounting research the world has to offer.

Speakers included Detroit's Deputy Mayor for Economic Policy and Planning Carol O'Cleireacain, GASB Research Manager Dean Mead, Detroit's CFO John Hill, and Auditor General of Canada Michael Ferguson. AAA-GNP Section President Royce D. Burnett and our own Ken Smith were co-chairs of the event. John and Ken presented their paper "How to Face Financial Reality: An Interdisciplinary Network Model of Local Governance Actors" to enthusiastic interest by other AAA-GNP members. Additionally, the AICPA reaffirmed its interest in integrating scholarly, practical, and interdisciplinary accountants into a singular institution of excellence under the Pathways Commission, and Ken Smith won an award for service above and beyond to the AAA-GNP Section.

"Quality of Washington State School District Financial Reporting Results from a Population-Wide Survey of Audited Financial Reports"

Abstract

We examined the population of audited financial reports from all of Washington State's 292 School Districts via the State Auditor's Office. We found that 19 percent of school districts do not produce audited financial statements, and an additional 34 percent have problems ranging from relatively minor to severe. Of the remainder, 46 percent are generally compliant, yet only one percent of school districts produce disclosures that fully comply with generally accepted accounting standards (GAAP). This rate and quality of disclosures is significantly less and of lower quality than many other systems of financial reporting. The current reporting system appears to have significant flaws.
