

AGA Is Now...AGA: What It Means for You

Even if you were not at NLT 2022, you may have noticed the updated logo and flurry of communication over the past month from AGA National. AGA announced its rebrand from "Association of Government Accountants" to "AGA", formally announced on February 24, 2022. With the announcement, AGA created a new tagline "Advance. Grow. Accelerate." to accompany the name change.

Additionally, AGA refreshed its logo to be blue and orange with a star (illustrated at the top right of the newsletter. According to AGA's press release, the name is expressed within the new logo: "The design represents AGA's commitment to elevating the standard of excellence in government accountability and advancing our members' professional expertise and opportunities. The design is bold, bright, and better equipped to represent our brand moving forward."

For years, AGA has stressed its missions regarding a new symbol of excellence and transparency in government accountability at all levels of government. Its original name (Federal Government Accountants Association) reflected its original focus on the federal government, but has since expanded that mission to include all levels of state and local government around the country.

AGA's website describes its approach using each pillar of its tagline:

"Advance sound financial practices, accountability, transparency and excellence in

government."

"Grow, learn, excel and engage through a network of likeminded professionals and leaders."

"Accelerate profession al careers through learning opportunities and the opportunity to earn a unique credential - the Certified Government Financial Manager, the only credential developed solely with the government financial professional in mind."

Q: What's unique about the Montgomery/Prince George's Chapter? What changes have you seen over time?

The integration of ERM is essential for the maturation of the ERM environment. Sessions will include integration of ERM with reporting, cybersecurity, collaboration strategies and enterprise-wide activities."

CARES Act Webinar (2 CPEs)

Webinar on April 20, 2022 from 2:00-3:50pm. Per the AGA website, "The Coronavirus Aid, Relief, and Economic Security Act, also known as the CARES Act, pumped more than \$2 trillion into the US economy to address the many challenges faced by the nation from the COVID-19 pandemic. However, this piece of legislation was just one of many related to COVID relief funding and oversight. Together these laws created a number of unique issues and requirements for the oversight and accountability community. In this session, learn from leaders in CARES Act and COVID-related accountability who will present both federal and state perspectives on this important area. GASB. Per a GASB news release, GASB is adding a "major project for going concern uncertainties and severe financial stress and pre-agenda research activity on subsequent events" to its technical plan for 2022.

The project will include considerations of improvements to existing guidance, defining "severe financial stress", and what information would be necessary to disclose.

GASB also issued a release that the Financial Accounting Foundation (FAF) named six new and reappointed seven existing members of the Governmental Accounting Standards Advisory Council (GASAC).

For academics and researchers, GASB has announced a request for research relevant to the GASB's standard setting activities as part of the Gil Crain Memorial Research Grant. Read more in the GASB posting on its website.

FASAB. No significant news for the period as a number of FASAB projects are ongoing. Projects include climate -related financial reporting, reporting model considerations, and technical clarifications of existing standards.

Federal Excerpts: Government Accountability Office (GAO)

GAO issued a number of recent reports and other documents as summarized in its most recent "Month in Review" on its website.

Of recent note, GAO released its audit report (with disclaimer of opinion) for the FY 2021 Consolidated Financial Statements of the US government. According to GAO, the primary challenges facing the U.S. government's financial results include financial management problems at DoD and SBA, unreconciled differences between federal agencies, and financial reporting weaknesses.

GAO also released several reports on data quality and financial systems. For one agency, GAO recommended a system migration plan to transition to its modern financial system. For another agency, GAO noted improvements in the implementation of a financial system and improving overall data quality but recommended that it facilitate an agreement on collecting standardized cost data and to establish goals and expectations for using the data.

MPG February 2022 Abbreviated Board Meeting Minutes

Treasurer: Wilson mentioned that he has completed all financial statements and they are currently in Nick's review but will go to Denise after for posting to the website.

Accountability: Brett stated that the Accountability committee is currently in the process of doing the CCR scholarship and sending out invitations to various schools. One team from Morgan State has already registered, but they are planning to re-send the invite to schools that haven't responded to see if there is more participation.

Awards: Anu mentioned that she has been looking into an inperson or hybrid awards event since Omicron is settling down. Nick mentioned that the only thoughts would be how to set up a projector or the visual aspect for those viewing in attendance and virtually. He also stressed that if we do a hybrid event, we need to take into consideration the engagement from both the individuals in-person and virtual.

Certification: Nick stated that Lauren held a CGFM study group about two or so weeks ago. There were a handful of individuals in attendance and Lauren was able to give a lot of helpful content. Nick also emphasized there is a good chance to win study guide

materials if you attend.

Young Professionals: Sarah stated the joint Young Professionals/ Membership Trivia Event is tomorrow and currently there are about 15 people registered. She encouraged individuals to invite others and register if you haven't already.

Membership: Tanequa stated that she is working on the membership satisfaction survey and hopes to send that out soon.

Education/Meetings: Toyin stated the Education/Meetings committee has had a lot of success with using Zoom. They have been able to use Zoom for polling rather than Conferences IO and registration through JotForm, which interfaces with Zoom. The Education Committee stated they had success with using JotForm.

The next education meeting is on Tuesday, March 15 on environmental social justice. This session is for 1 CPE in specialized knowledge and consists of a presentation by Corinne Dougherty. Carol emphasized that a flver was sent out for this meeting, which has been shared with friends and on social media.

The Spring Workshop is on April 7 from 8am to noon. Carol wanted to get the board's thoughts on giving speakers for Education

Committee events an allotment of free attendee vouchers for the workshop.

Historian: Jeff informed the board that he is still updating the website and information. Nick mentioned to the board that he wanted to celebrate and recognize Jeff's 40 years as a member.

Newsletter: Matt stated that based on the timing of awards, he wanted to start the next newsletter now. He also mentioned that instead of rushing the last newsletter, he wants to delay it until after the awards ceremony so that he can include the highlights from the event.

Recognition: Jillian stated the next reporting for recognition will occur on February 18 and will include all chapter accomplishments from December 2021 through February 2022. Denise sent out a monthly email reguest last week and Carol asked for the email to be sent out with a new title. Denise said she will aim to send a draft email next week. Denise also said she added the chapter events to the AGA National website to be posted for March.

Special Projects: Nick stated that the chapter is currently looking for someone to do a financial review of our finances, not an audit. He is currently looking into non-local chapters.
