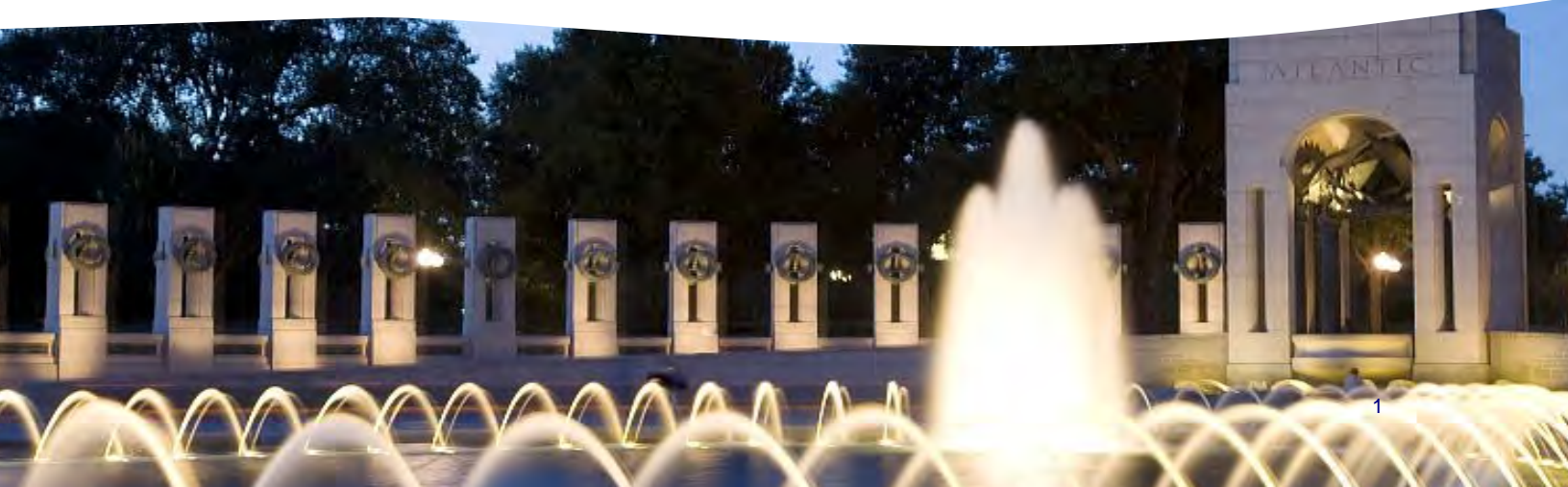

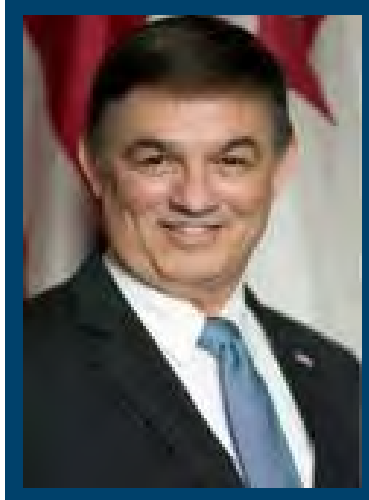

Get to Know January Luncheon Speaker Jeffrey S. DeWitt



Jeffrey S. DeWitt is the chief financial officer (CFO) for the District of Columbia and is responsible for the District's finances, including its approximately \$13.4 billion budget, the majority of which (\$8 billion) is generated from local revenue sources. He also manages the city's \$6.3 billion capital improvement plan budget. Mr. DeWitt was appointed to this position by Mayor Vincent C. Gray and confirmed by the city council to complete Natwar M. Gandhi's five-year term through June 2017.

As the independent CFO, Mr. DeWitt manages the District's financial operations, which include more than 1,000 staff members in the tax and revenue administration; the treasury, comptroller and budget offices; economic/fiscal analysis and revenue estimation functions; all District agency financial operations; and the DC Lottery. He is also responsible for coordinating with congressional committees and the US Office of Management and Budget staff that oversee District affairs. He regularly interacts with the financial community, including rating agencies, regarding the District's financial matters.

Previously, Mr. DeWitt served as CFO for the city of Phoenix, the 6th largest city in the United States with a \$3.4 billion annual budget and nearly 15,000 employees. There, he managed a \$7 billion debt portfolio and more than \$2 billion in investments. He was a member of the City of Phoenix Employees Retirement Board, the Phoenix Community Development Investment Corporation, the Phoenix Downtown Hotel Corporation and Arena Development Board.

As CFO for the District of Columbia, Mr. DeWitt sits on the boards of the Washington Convention and Sports Authority (EventsDC) and Destination DC.

Jeffrey DeWitt is a member of the Government Financial Officers Association (GFOA), the American Accounting Association (AAA), Association of Government Accountants (AGA), and the American Water Works Association (AWWA).

He holds a master's degree from Southern Illinois University, Carbondale, and a bachelor's degree from Eastern Illinois University.



Remembering

Relmond P. Van Daniker, DBA, CPA

1942–2016

In celebration of his life and contributions to the government financial management community.

Dr. Relmond Paul “Van” Daniker passed away November 17th at his home in Lexington, Kentucky. He attended the Air Force Academy in Colorado, received his undergraduate accounting degree from Loyola University, his master’s degree in finance, and his doctorate in business administration from the University of Maryland.

Among his many accomplishments, he was among the inaugural group inducted into NASACT’s Hall of Fame in 2015. He served as CEO of the Association of Government Accountants in Alexandria from 2003 until his retirement in 2014.

Upon his arrival to AGA, the \$3-million-a-year operation grew to an annual budget of nearly \$7 million, in addition to the staff growing from 20 to nearly 30. Van worked tirelessly to advocate for government accountability and fiscal transparency, championing Citizen-Centric Reporting that opened the doors of government to the citizens. He was a past national president of the International Consortium on Governmental Financial Management (ICGFM), a member of AGA, a longtime member of AGA’s Central Kentucky Chapter and a member of the American Institute of Certified Public Accountants (AICPA). He was the recipient of numerous awards, including AGA’s Author and President’s Awards.

Van is survived by his wife of 50 years, Dolly, their five children, and 12 grandchildren.

Certified Government Financial Manager (CGFM) Committee Updates by Wendy Allen

As we find ourselves amidst the holidays and the season of giving... consider giving yourself the gift of achievement by obtaining the CGFM! Passing the CGFM exam and obtaining that certification is a worthy way to demonstrate your commitment and dedication to the industry! The AGA DC chapter CGFM Committee is very excited to provide you with some opportunities to help make that gift achievable in 2017!

Exam Rebate Initiative – Take the exam and pass it during the months of January, February, or March and we will reimburse you the cost of your exams! You must submit the passing certification per module in order to qualify for the rebate. Reimbursement cost for each exam is \$125! Exclusions apply to those who receive reimbursement from employers.

Chapter CGFM Classes – The DC Chapter is planning on hosting a six day training for all three modules of the CGFM exam. The cost is \$600 per person and the CGFM committee will pay \$300 towards each individuals training class. All fees are due prior to the start of the class. This will cover all training materials and the instructor. Room is limited at 30 individuals only. Class dates are to be determined. This is not a guarantee of acceptance, when we have finalized dates we will send out an official application email.

Did you know that to maintain your CGFM, all those who are active are required to complete at least 80 hours of continuing professional education (CPE) every two years in government financial management topics or related technical subjects. The 80 CPE hours must be completed within the CGFM's two-year CPE cycle. The CPE cycle is determined by the CGFM award year.

Additionally, active CGFMs are required to maintain supporting documentation on CPE hours earned for a minimum of three years and provide it to AGA upon request. This documentation may be requested by AGA as part of an annual audit of a random sample of CGFMs.

Hear from Early Career Member Charles Moka (Bowie State University December 2016 graduate)

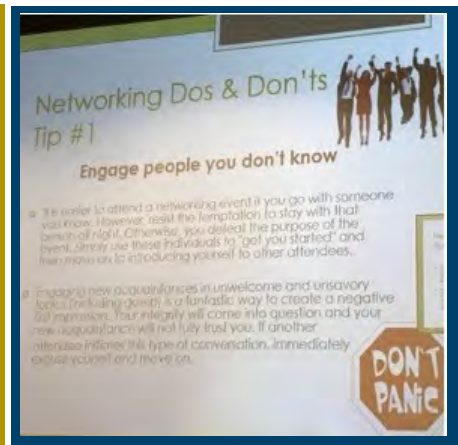
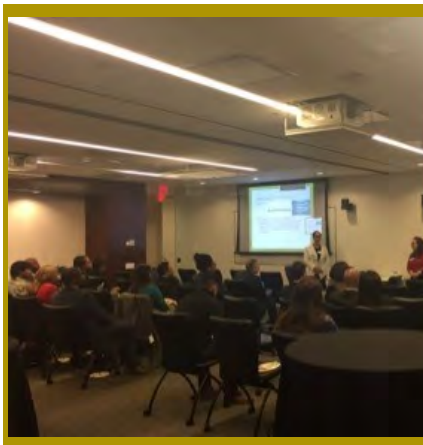

Inside the Black Box

Different Types of Budgeting

Introduction

The GAO conducted studies in 2000 and 2007 on accrual budgeting. These are interesting, but rather long, so I thought I would relate some of the highlights and if it piques someone's interest, they can easily find them on the GAO web site.

Cash Budgeting

The most common form of budgeting is based on cash. Historically, this was the only kind of budgeting, because governments could not make money, only collect revenues and the cash in the treasury limited how much was spent. Cash budgeting emphasizes spending controls. Many governments still use cash budgeting; in the U.S., arguments over the debt ceiling are a remnant of cash budgeting.

Obligation Budgeting

The U.S. currently uses obligations-based budgeting. The main difference between obligations and cash is timing: the budget is considered used when an order is placed with the vendor. Perhaps the largest difference is found with capital leases from non-federal vendors, where the total present value must be obligated up front for payments made years later.

Accrual Budgeting

Accrual-based financial statements are more useful than cash-based ones, so many governments have switched to an accrual-based budget to match their basis with their financial statements (and finally get rid of the Statement of Financing, now O-136 note 42). The real advantage to accrual budgeting comes in realizing the long-term costs of legislation, since today Congress only has to look at costs ten years out. It also supports full cost measurements, so what an agency budgets for payroll has to include expected pension costs. However, it can be difficult to estimate the actual cost of a program decades in the future, and determining the interest rate to discount the future flows, as many agencies discovered with credit reform in 1990.

Also, accrual budget require an agency which purchases an asset such as a building to have guarantees of enough funding to cover the depreciation each year for the life of the asset. They also have to have some additional restriction in the current year, or they could spend a lot of cash buying long-lived assets. Many countries grant cash warrants that match the appropriation, which means it is much easier for an asset-rich agency than an asset-poor agency to purchase new or replacement assets, since the depreciation and usage literally puts cash in their pockets.

Accrual budgeting has only been implemented in countries that have a parliamentary system, where the current government controls the legislature and appoints the heads of the ministries. In the U.S. system, where the chief executive draws up the budget which then has to be passed by a sometimes hostile legislature, it's not clear if agencies will always get enough budget authority to cover costs that have already been paid for.
