# **Opportunities to Connect and Network with Students**

Are you interested in talking about a career in government and connecting with students, or do you know someone in our field who might be? One of our strategic goals as an Association of Government Accountants (AGA) chapter is to reach out to local colleges and universities and talk to students about opportunities in government accounting, finance, and accountability careers. Many school programs focus almost exclusively on recruiting for large and medium sized public accounting firms and private companies, and students have very little exposure to opportunities with government employers.

We are in the process of reaching out to local student groups to set up virtual events. In past

years, we have met in person with students. In past years, we have met in person with students on campus, putting together panels of government professionals to talk with students about their own careers, career opportunities for students, skill sets needed at their workplace, etc. We plan to do the same this academic year, but virtually until it is safe to attend events in person. We have events tentatively planned with Seattle University's Beta Alpha Psi students on Thursday, January 20, 2022 from 12:30pm to 1:20pm; and University of Washington - Bothell Campus students on Thursday, February 10, 2022, from 4-**5pm.** Depending on the level of interest by chapter members, we would likely give each presenter 5 to 10 minutes to present, with time for questions at the end. These are great opportunities to reach students, and to share opportunities at your place of work. We also plan to arrange events at other Washington schools as well.

#### National Council of Chapters (NCC) Representative Update

Representing our chapter on the National Council of Chapters (NCC) provides an opportunity to connect with chapter representatives from all over the country four times a year. Over the course of three virtual meetings this year, I have had the chance to hear from AGA National staff, and AGA National Governing Board members, on a variety of AGA-related topics. Also to talk with other chapters about challenges and successes for our chapters, and how we can work together to improve experiences for all of our members.

Our first meeting in April was essentially an orientation to the Council and our roles as chapter representatives. This included information on the governing structure for AGA, the purpose of the Council, and responsibilities of Council members,

At our second meeting, on August 24<sup>th</sup>, we received updates on chapter health from Melinda Miguel, AGA National President-Elect; and on overall membership numbers, and the new "<u>Everyone Get</u> <u>One</u>" member recruiting campaign from Susan Fritzlen, AGA COO. Ann Ebberts, AGA National CEO, discussed the transition of the Internal Control and Fraud Prevention Training to all virtual, and also progress being made on a major upcoming AGA re-branding project. We also broke up into breakout rooms, and discussed a variety of chapter related topics in smaller groups.

We also learned about AGA's Council for the Advancement of Women. This group is comprised of members who act on behalf of AGA to manage gender diversity initiatives and progress. The Council has a series of eight initiatives across broader goals of opportunity, education, action, and connection. Our most recent meeting, on November 2<sup>nd</sup>, covered a similarly broad array of topics. We

touched on chapter health metrics, learned about making requests for guest speakers, and met the new director for chapters in Area 7 (Northeastern States). The AGA Seattle Chapter submitted its annual Citizen-Centric Report to AGA National in October 2021. We express gratitude and thanks for Chapter member E. Stephen Kim for his meaningful contributions to this year's CCR while he served in an Advisory role to the Board.

AGA's Citizen-Centric Reporting (CCR) initiative is intended to foster innovative means of communication between governments and their citizenry. AGA believes government financial and accountability information should be provided to citizens in ways that are clear and understandable, updated regularly and often, broadly delivered, easy to locate, honest in breadth and accurate in detail. Our 2019-2020 CCR was awarded the



Certificate of Excellence by National and we hope to receive the same accolade this year. During the judging and awarding process National provided us with extensive feedback on our 2020 CCR that we strived to incorporate in to our 2020-2021 CCR. One piece of feedback was to include more metrics and trend data. We encountered some challenges implementing this feedback in some areas due to this being the first year of the ACE Award framework, but we have set ourselves up to successfully track and incorporate this level of trend data in the future.

We welcome the new members to the AGA Seattle Chapter and welcome back our continuing members.
