The meeting was called to order by our President, Ann Martinez. We met at Tico's, 317 S. 17th St, Lincoln, NE.

The 14 year old son likes computer gaming, but not knowing what system they have a Target gift-card would be welcome. For the mother cleaning supplies and blankets would be welcome.

Ann announced that the January Chapter meeting will be held January 8 since the first Wednesday is a holiday. This meeting will be held at daVinci's, 11th and G Streets. The speaker will be Philip Olsen, State Accounting Administrator.

Ann announced the spring PDT will held May 14 at Innovation Campus. Topics and speakers are yet to be decided.
