The underlying concept of the seminar is that an accounting system should be responsive to the needs of various users, in addition to the operations accountants themselves. For example, the computer center is responsible for the data processing related to accounting and therefore has more than a casual interest in the system's design. Likewise, an agency's department managers, most of whom are nonaccountants, depend on the accounting system to provide financial management reports essential to the processes of program control and planning for the future. The auditors, both internal and external, are yet another group who can perform their activities more effectively if the system is provided with good audit trails and controls.

PRESIDENT'S MESSAGE

In this issue of the *Newsletter* we announce the results of the Chapter Election, the composition of the New Chapter Executive Committee and the Program for the year ahead. The officers and directors you have selected and the committee chairmen and many members who have volunteered are deeply appreciative of the opportunity to serve you. We are also very much aware of the duties and responsibilities we have assumed in accepting this honor.

This Chapter is large and its responsibilities to the association and to its membership are commensurately great. The needs, desires and composition of our membership have been revealed in the National Education and Training Committee's survey which was conducted last year under the able leadership of Mike Simon and ably analyzed and reported by Jerry Murphy in the May issue of the *Washington Chapter Newsletter*. This Survey appropriately marks the beginning of an era as we enter the twenty-fifth year of our Charter as an association dedicated to the "Improvement of Financial Management in Government".

We enter this era with a mandate from the membership. The Survey baldly reveals the context and the scale in which we must conduct our activities. The Chapter organization is, and rightly should remain, the front line of our Association. All chapters share these responsibilities and must acquit themselves professionally if this association is to continue in the vital role it has outlined and thus far progressed.

Our theme, in this our twenty-fifth year, has been suggested as a basic reaffirmation of our charter through reemphasized cooperation with the agencies and organizations from which our membership is drawn and with the professional associations which form the spectrum of disciplines in our field of endeavor.

In striving for better administration and accountability in the public sector the dialogue between the professionals and professions concerned must be improved and strengthened. Barriers must be lowered or removed. Each profession or discipline cannot be satisfied with carving out a parochial corner or "bit of turf" and expect improvements in the total process of management to follow in the normal course of events. The program this year will be conducted to reflect this theme by focussing the talents of the Directorate to these primary objectives: close cooperation with the agencies from which we draw our membership and the selection and development, in depth, of topics on which the dialogue with other professional associations can be developed.

A transitional meeting of the Washington Chapter Executive Committees, old and new, was held on June 7, 1974. In this meeting the 1974-5 Chapter objectives, theme and program outline were unanimously approved. The newly elected Directors, Committee Chairmen and women accepted their duties and responsibilities for the coming year and an interim budget was approved - to take effect July 1, 1974.

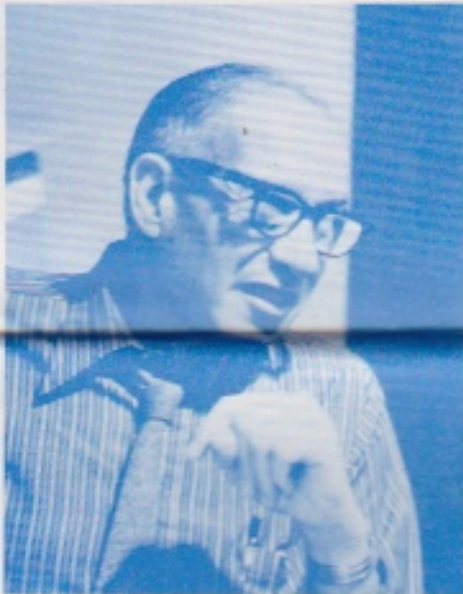

Peter Drucker



"The management boom, as all such booms must, overreached itself and came to an end. The first sign—and this too is typical of a boom—was the appearance of books that predicted the management boom would last forever. In 1967 the American economist J. Kenneth Galbraith predicted in a worldwide best seller...that professional management in big corporations, armed with all the tools of modern management techniques, has become invincible.... This prediction appeared at the moment when professional managers began to be unseated right and left by the takeover-raiders...."

That quotation, more than somewhat surprisingly, comes from a new book, "Management: Tasks, Responsibilities, Practices" (Harper & Row, \$15). The author is Peter F. Drucker, economist, philosopher, consultant, college professor, writer and—in the public's view—the star of the management boom.

The boom, however, did things that Mr. Drucker deeply disapproves of. It persuaded many businessmen that the right collection of formulas and techniques, stirred with a little jargon, could perform marvels in each and every organization. Possibly as a result of some debacles such as the Penn Central collapse, he says, managers themselves have come to realize that "management is challenge and work rather than a panacea."

It's Mr. Drucker's belief that everyone is interested in management, whether he realizes it or not. Our society has come to be dominated by large institutions—private corporations, government agencies, public-service organizations and all the rest. We have a large stake in how they are managed.

What's wrong with management in government and other service institutions, he argues, is not the people but the system. Conservatives may talk of making government more businesslike, and yet when businessmen move into government they often turn into bureaucrats.

But the basic job of management, Mr. Drucker contends, is not making decisions and solving problems but determining what the problems really are. Once the organization knows what its function is, the rest of the management job is simpler. Too many organizations flounder around and die because they have no clear idea what they should be doing.

PAUL GREEN FGAA FOUNDER DIES



FGAA mourns the death of Washington Chapter Member Paul M. Green. Memorial services were held for Mr. Green in Urbana, Illinois, on May 15, with burial in East Liverpool, Ohio, the following day.

Mr. Green held membership certificate number 2, immediately following Founding President Robert W. King's certificate number 1. He served, with President King, as the first vice-president of FGAA.

The Truman Library in Independence, Mo., had made preliminary arrangements with Paul to obtain papers relating to AEC Operations during the Truman Administration.

Mr. Green was the first civilian comptroller of the Atomic Energy Commission and was responsible for the first major installation of Cost Budgeting and Accounting in the Federal Government.

He was the first comptroller of the Foreign Aid Agency; Assistant Administrator of Price Stabilization; Deputy Assistant Secretary of Defense; and Deputy Assistant Administrator of OPA under Chester Bowles.

After leaving government, he was Dean of the College of Commerce and Business Administration at the University of Illinois, and was later affiliated with Florida Technological University and Stetson University. He remained a consultant on accounting and management to a number of government agencies until his death.

A proposal to establish a Memorial Fund for members contributions is being considered by the Washington Chapter Executive Committee.

RETIREMENT OF CLAYTON P. BALZER

Clayton P. Balzer, an FGAA member since 1957, retired June 7, 1974, after nearly 35 years with the Federal Government. Balzer has been with the U.S. Information Agency for over 20 years, and was Chief of the Agency's Financial Management Systems and Planning Staff, Office of Administration and Management, at the time of his retirement. He was Assistant Treasurer of FGAA in 1960-1; member of the Roster Committee in 1963-4; and member of the Membership Committee in 1964-5 and 1965-6.

Minority Business Training Courses Cite Improvement

With a years experience to rely on, the Minority Business Training Program made excellent progress, both in quality of instruction and quantity of students, almost doubling the number of graduates from the course taught in Washington, D.C. a year ago. There were nineteen certificates given out on June 6, 1974 to class members. A minor setback occurred when the first class conducted for Annapolis participation at Hampton Mall began at the start of the gasoline shortage. This obstacle was quickly disposed of by a student carpool from Annapolis.

Contributing to the success of this years program was the work done by Mike Nathan, CSC, who was responsible for instructor selection, David Suing, Navy Comptroller, who coordinated student input and Jim Stewart, METRO, who coordinated counselor support. The small, but effective, group of counselors assisting the students included Frank Gladden, ACTION, Joyce Charles, Commerce, Ed Boicourt,

GAO, Maria Hykes, ICC, and Henry Young, DCAA. The coordinators also "Doubled in brass" acting as counselors as well. In addition, it was a prerequisite that all instructors be counselors to better understand their students. The OMBE coordinator for the program this year was Mr. Anthony Pitt. Mr. Pitt was instrumental in acquiring the large student turnout from Washington, D.C. with his sponsorship letter to the various Business Development Organizations. According to Perry Duncan, Director of OMBE Training, as the word spreads it is obvious that our classes will grow in size as we have received enthusiastic comment from all class members to date. It is hoped that next year will see some new counselors to assist the old hands, the majority of which have been working on the program for two years. Mr. David Suing has agreed to chair this program next year. If you are interested in assisting him, be sure and let him know.

Seminar for New Managers Off and Running

The U.S. Civil Service Commission reports that the second of the two pilot sessions of the three-week "Seminar for New Managers" was successfully completed on May 24, 1974. This seminar has been developed specifically to provide learning opportunities in many of the managerial skills and knowledges needed by persons assigned to their first managerial position (newly selected managers as defined in FPM Letter 412-2, January 29, 1974).

Sixty agency managers attended the two pilot sessions conducted at Skyland Lodge, Shenandoah National Park, Virginia. The students came from twenty separate agency organizational components with well over one-half occupying field managerial training needs.

In FY 1975, eight sessions of the "Seminar for New Managers" are scheduled in each of the three Executive Seminar Centers at Oak Ridge, Tennessee; Kings Point, New York; and Berkeley, California. The Commission has informed agencies that it will provide additional sessions if required to respond to agency new manager training needs.

Space requests for attendance in the Executive Seminar Program should be made through the headquarters offices of each agency. Persons who have been assigned to their first managerial position since July 1, 1973, are eligible to attend and should make their request through their local training officer to the appropriate headquarters office.
