THE 2022 PDT- UPDATE

October 17 and 18, 2022

The 38th Annual Professional Development Training Conference will also be the 1st Hybrid Conference.

We will be returning to the Quest Conference Center 9200 Worthington Rd, Westerville, OH for an in-person conference and hope to see most of you in-person again.

The in-person conference to be in a similar format as the past with some general sessions for everyone and some sessions which will run concurrently as three break-out sessions where you can choose the topic to attend. For those who elect to attend virtually, we will only be able to live stream one of the break-out sessions. More reason to attend in-person if you are able, for a wider selection of sessions to choose from.

We will provide similar options, as in the past, for breakfast and lunch along with refreshments during breaks.

We believe the 2022 PDT will deliver an excellent professional training experience over 2 days, Monday October 17 and Tuesday October 18, 2022, providing up to 16 hours of CPE for those who need it, at a bargain price.
