## **Inside The Black Box**

## **Changes in the Statement of Budgetary Resources**

#### **Background**

The Statement of Budgetary Resources (SBR) for FY2019 is considerably shorter than the FY2018, but more complicated.

#### **Beginning Balance**

The primary change in Section 1 Budgetary Resources is that the beginning balance and changes to the beginning balance are merged into line 1051 Unobligated balance from prior year budget authority. Previously, line 1051 had been a total of four lines, but now it is calculated based on account balances. However, three of those lines, 1020 Adjustment to unobligated balance brought forward, 1021 Recoveries of prior year unpaid obligations, and 1043 Other changes in unobligated balance, are now combined into a memorandum line 1980 Net Adjustments to Unobligated Balance Brought Forward. The balance of 1980 plus last year's line 1000 Unobligated Balance Brought Forward is the new balance for line 1051.

Combining these lines may simplify the SBR presentation, but it complicates the compilation, because these lines include some very different balances. One can't just create the balance of new line 1051 by using the balances of all the Standard General Ledger (SGL) accounts listed by Treasury, because many of these account balances are reported on other lines, and this will lead to double counting. Instead, the new line will need the three types of balances that had previously been reported on separate lines:

- 1. Beginning balances (old line 1000): The report is set up so that the total of sections 1 and 2 should agree. Most accounts only report their activity for the year. Available authority accounts (SGL 442000 through 472000) report their ending balances in section 2, and their beginning balances have to be reported in section 1 as an offset. Because most of these accounts close at year end, the only SGL accounts in this series that should have beginning balances are 445000 Unapportioned Authority, 462000 Unobligated Funds Exempt from Apportionment, and 465000 Allotments Expired Authority. I prefer to take the beginning credit balances of the available accounts and flip the sign so they display as a positive number. Treasury recommends taking the beginning net debit balances of all other budgetary accounts and back into the available amount.
- 2. Prior-Year Adjustment Activity (old line 1020): Postings in any account other than the available authority and transfers of obligations and reimbursements where the Prior-Year Adjustment Code is B or P.

3. Normal Adjustment Activity (old lines 1021 and 1043): Any activity in the following SGL accounts where the Prior-Year Adjustment Code is X. These accounts' balances are not reported elsewhere in sections 1 or 2: 404800, 411601, 413400, 414400, 414700, 415200, 417600, 418000, 419000 thru 419200, 419700 thru 419900, 429500, 432000 thru 436000, 438500, 439600, 439701, 439900, 487100, 487200, 497100, and 497200.

This would also include only debit balances of 431000 Anticipated Recoveries of Prior-Year Obligations, because credit balances are reported on line 2404 Unapportioned, unexpired accounts.

This also means that the activity of only a few SGL accounts is excluded from SBR sections 1 and 2. Ignoring the accounts exclusive to the International Monetary Fund, these are the accounts associated with nonexpenditure transfers of budgetary resources: 408100 through 408300, 419500, 423000 through 423400, 483100, 483200, and 493100; as well as 414500 Borrowing Authority Converted to Cash and its offset account 414800 Resources Realized from Borrowing Authority.

#### Change in obligated balance

Section 3 of the SBR has been removed in its entirety. Lines 3000 thru 3200 are no longer needed.

#### **Budget authority and outlays, net**

Section 4 of the SBR has been drastically reduced to three lines, only one of which can be calculated directly from SGL balances. The old line 4190 Outlays, net was the sum of lines 4185 Outlays, gross and 4187 Actual offsetting collections. Fortunately, the new line 4190 just sums the balances of the same accounts, which basically are all cash budgetary accounts from 421200 through 498200, except for the withdrawal accounts of the 435000 through 439900 series, and the transfer accounts 423100 Unfilled Customer Orders with Advance – Transferred and 483200 Undelivered Orders - Obligations Transferred, Prepaid/Advanced.

#### **Conclusion**

This new format is already in force, though it's possible to fake it by producing the old format and cutting out the lines that are no longer reported. If your agency hasn't updated your SBR definition, now is the time to do it.


