Governments at all levels — federal, state and local, are making major strides in providing access to financial data on open data websites. While state governments and federal agencies might have several people on staff who can compile reports, local governments might find Citizen-Centric Reporting (CCR) especially conducive to easily providing citizens with a lot of information in a short, easy-to-read format.

Reports should answer the questions citizens may have about their governments' priorities, program performance and accomplishments, and focus for the future. Citizens should easily be able to find a succinct, clear, plain-language summary of spending and performance. Do your current reports allow citizens to do that? If not, check out CCR. It can be the mechanism in providing honest, direct, and simple information in a visually appealing four-page report. The CCR initiative marks its 10th year in 2017, and in that time, the public sector has produced more than 400 reports for citizens nationwide.



Have you thought about becoming a Certified Government Financial Manager (CGFM)? If you have, all it takes is a little time and effort to get it done. There are three training venues that can help you prepare to take and pass the three examinations. The first is three open enrollment courses offered by Management Concepts www.managementconcepts.com. The three courses are:

- Governmental Environment (1 day course)
- Governmental Accounting, Financial Reporting and Budgeting (3 day course)
- Governmental Financial Management and Control (2 day course)

The second venue, if you prefer not to travel, is self-study using the three CGFM Study Guides. These study guides are available hard copy or on-line. The New Mexico Chapter also has these study guides available for check out.

The third option is to take the Intensive Review Course. This course is a special, limited enrollment opportunity for individuals who have already been studying for the CGFM examinations and want extra reinforcement of the material.
