CGFM CANDIDATES OFTEN ASK "WHAT IS THE BEST WAY TO STUDY?"

THERE ARE MANY APPROACHES. IN THIS MONTH'S ISSUE, WE WILL OUTLINE THE APPROACH THAT AGA RECOMMENDS.

- 1.) Review the examination's content outlines that list the main and subtopics covered in each examination. This should be the focal point of your preparation. It is the core document used as the basis for each examination and a guideline for writing examination questions.
- 2.) Customize your preparation process. The examinations are rigorous. Don't underestimate the need to study and be prepared. There are a number of options available, including instructor-led courses and self-study guides. Review each option to determine what works best for your level of knowledge, learning style, budget and time constraints.
- 3.) Decide on which study option works best:

Most AGA Chapters offer classroom instruction to assist in passing the CGFM exam. The Albuquerque Chapter and New Mexico Chapter jointly conduct annual CGFM training events. Contact any of our Albuquerque Chapter Executive Committee (CEC) members for information on registering for the next event.

AGA National's Intensive Review Course (IRC) event serves as a concentrated refresher course and is followed by an opportunity to take the examinations immediately following the review. It is a great opportunity to review the course material with a knowledgeable instructor and complete your CGFM! The two-day IRC runs from 8:00 a.m. – 5:00 p.m. both days, and offers up to 18 CPEs.

If you are looking for a cost-effective way to study at your own pace, AGA offers CGFM study guides in two convenient formats: A printed version and a one-year online subscription. An option is also available to purchase both formats as a bundle.

<u>Printed Version:</u> These three comprehensive publications benefit both CGFM candidates and those who wish to advance their knowledge of government financial management in general. The study guides feature a textbooklike format, with learning objectives, a summary, and a reinforcement quiz included in each chapter. In addition to the relevant resources, the appendices contain a glossary of terms, a list of reference materials, answers to reinforcement quizzes with explanations, and end-of-course review questions. Individuals ordering the study guides can purchase the option of earning self-study Continuing Professional Education (CPE) hours upon passing an online CPE quiz.

<u>Online Subscription:</u> The online subscription option offers the same benefits as the printed version, but also offers the ability to review the content on your laptop, tablet or phone, and access new editions if they are published within your subscription period.

- 4.) Work with others within our chapter to form study groups and share study guides.
- 5.) Review the CGFM Examinations sample questions. These questions are designed to provide you with a sampling of the format and types of questions you can expect on the examinations.

On September 20, 2016, Amy Carter of Moss Adams LLP gave a luncheon presentation to an attentive audience about changes and updates to Sub-Recipient Monitoring, Cooperative Audit Resolution & Allowable Costs at Pappadeaux Seafood Kitchen. Amy provided insight to attendees about updates to the Uniform Grant Guidance, with the overall consolidation of 8 OMB Circulars, as well as updates to the topics of Allowable Costs and Sub-Recipient Monitoring. She discussed detail about determining the difference between contractors and sub-recipients, which always creates good discussion and dialogue about its decision-making! In another relevant area for our participants, the need for cooperative audit resolution, and helpful techniques for achieving was highlighted. The approach relies on the critical skills of effective communication, collaboration, and trust between auditors and clients. Amy's presentation provided helpful tips and answers to questions posed about all the included topics, and we were happy to have her share with us!

Succession Planning with Denise Montoya, Ph.D

Every day approximately 10,000 baby boomers are retiring out of the workforce. That's a reality that both private business and government entities must face. Our October Seminar speaker, Denise Montoya, Ph.D., SHRM-SCP, SPHR will be discussing how this retirement wave will affect government entities in particular, and what they can start doing now to decrease the damaging effects.

Dr. Montoya achieved her Ph.D. in Organization, Information, and Learning Sciences at UNM. She is a published co-author for topics including a Model of Shared Leadership as well as Building Trust in Virtual Teams. Dr. Montoya served as the former Executive Director of Human Resources (HR) with Central New Mexico Community College (CNM) and former Director of HR Client Services at the University of New Mexico (UNM).

ALBUQUERQUE AGA MEMBER SURVEY

The link to our member survey was sent to full membership during May 2016, and was open for 3 weeks. We received a response rate of 35% (47 of 135 members). Major takeaways were presented at the July CEC meeting, and responses determined and noted below.

Members find the most value in the CPE offered by the Chapter

Although many are not interested or are not able to participate in the mentor program, contact info for those interested was gathered and will be held for future mentoring sessions

Based on interest suggestion, we will consider adding a section in our newsletter and website to post resources about changes to standards and other industries.

The CGFM promotions the Chapter offers are not reaching some members and about a third of members are not aware.

CEC Response:

We will continue to announce and promote the benefits and opportunities offered at the local and National levels.

A majority of respondents are already CGFM's or not interested, and there was no expressed interest in conducting a National intensive session locally to teach the certification material.

CEC Response:

We will work to provide other options for CGFM certification support, such as our "You Pass, We Pay, and will also implement a Test 2 intensive training this year to enhance our approach for more in-depth instruction sessions.

A majority of respondents are interested in webinars, as it garnered the highest response rate. We have not historically provided webinars based on audio and topic quality.

CEC Response:

We will continue to provide a variety of choices and topics to provide education opportunities.

Responses showed that members are interested in all types of training and topics. The survey responses indicate that more people are interested in luncheons, but in practice more people show up for the longer sessions.

CEC Response:

Further input from other chapters in our region highlighted their improvement in the last few years, and we will hold two sponsored sessions at local firms for this program year.

There was not high consensus for good or bad timing for the CPE sessions. A majority agreed that Fall (Sept – Nov) is difficult timing. Summer was also shown to be a hard time for our state government employees.

CEC Response:

Based on this feedback, our program is better from December through June for state government employees, and the summer and fall could be more beneficial for local and federal government employees. We will continue to provide a variety of options throughout the year to allow opportunities for all members, and work to tailor topics that will apply to each during noted timeframes.
