# **Meeting Minutes**

## February 13, 2007

Jerry welcomed everyone and called the meeting to order at 12:05 PM. Cindy Stein moved that the minutes and treasurer's report be approved; Dr Nichols seconded and the motions passed by voice vote.

Jerry reviewed up-coming meetings and indicated the March meeting would be a two-hour meeting. There was a brief discussion about having a spring seminar. Donations in the form of checks for the Ozark's Food Harvest are requested for the March meeting.

Efforts will be made to reach out to the Missouri State University Accounting department and students in order to effect participation similar to that of Drury University.

Jerry mentioned the scholarships for the Professional Development Conference in June are still available.

Jerrv introduced the speakers Morelock and Jeff Roberts. Ms Morelock first regarding what forensic spoke accountants do and various types of fraud she has investigated. She reviewed the annual cost to business that fraud causes. Mr. Roberts then spoke about methods that can be utilized to prevent or detect fraud. He recommended having a hotline to report suspected fraud, setting a tone at the highest level of ethical behavior, fraud awareness training, separation of duties possible and establishing whenever perception of detection. The speakers talked about what a career, as a Certified Forensic Accountant both requires professionally and personally. Then they took time to answer questions.

Jerry thanked both speakers and adjourned the meeting at 1:30 PM.



# **Technology Tip of the Month**

Compliments of one of our previous speakers, Terry Moore City of Springfield Finance Department





#### Start by selecting the empty cells:

- 1. Select the cells in the column, starting in the row below the column heading.
- 2. Choose Edit | Go To
- 3. Click the Special button

Select Blanks, click OK

### Enter the formula to copy the value:

- 1. Type an equal sign
- 2. Press the up arrow on the keyboard -- this will enter a reference to the cell above -- cell A2 in this example

Hold the Ctrl key and press Enter -- this enters the formula in all selected cells

#### Change the formulas to values:

In order to sort or filter the data, the formulas must be changed to values.

- 1. Select the entire column
- 2. Choose Edit | Copy
- 3. With the column still selected, choose Edit | Paste Special
- 4. Select Values, click OK

**Note**: Do this carefully if there are other cells in the range which contain formulas.
