ABOUT THE SPEAKER

Clyde E. Jeffcoat is Director of the Defense Finance and Accounting Service—Denver Center. He is accountable for the operation of the worldwide Air Force accounting and finance network, and for the development and maintenance of related financial systems. His organization accounts for all current and prior year monies available to support the Air Force mission. Collectively, these funds total \$138 billion.

Mr. Jeffcoat was born in Galveston, Texas, January 23, 1943. He graduated with honors from the University of Texas at El Paso with a Bachelor's degree in Business Administration. He earned his Master of Arts degree in Management and Supervision from Central Michigan University. He is a Certified Public Accountant and a Certified Internal Auditor.

Mr. Jeffcoat began his professional career with the accounting firm of Peat, Marwick, and Mitchell. He joined the staff of the U.S. Army Audit Agency at Fort Bliss, Texas in 1966. He served three tours in Vietnam, working for the Army Audit Agency and as Chief of the Defense Audit Service operations in Southeast Asia where he was responsible for auditing military assistance provided to Vietnam and Cambodia.

He returned to the United States in 1973 and was assigned to St. Louis, Missouri, as the Audit Director for the Army Audit Agency operations in that region. Two years later, he became Director of the Joint Financial Management Office, Defense Security Assistance Agency in Washington, D.C. He transferred to Denver, Colorado, in 1976 to establish and direct the Security Assistance Accounting Center and served in that position for three years. In 1979, Mr. Jeffcoat was selected to be Deputy Auditor General of

the Air Force where he managed 1,200 auditors and provided audit services to the Chief of Staff and Secretary of the Air Force.

From 1980 to 1987, Mr. Jeffcoat was Principal Deputy Commander at the U.S. Army Finance and Accounting Center, Indianapolis, Indiana. He was promoted to Director of Finance and Accounting for the Army in 1987, reporting to the Assistant Secretary of the Army for Financial Management. In 1990, his job title was changed to Deputy Assistant Secretary of the Army for Finance and Accounting. As such, he managed finance and accounting policies, systems, and operations of the Army, and oversaw the activities of 18,000 personnel located at 300 field offices around the world, as well as the 2,500 employees at the finance center.

A member of the Senior Executive Service, and previously a supergrade since March, 1977, Mr. Jeffcoat has received 28 major awards including both the Distinguished and Meritorious Presidential Rank Awards, the Army Decoration for Exceptional Service, the Republic of Vietnam Honor Medal, the National Distinguished Leadership Award from the Association of Government Accountants, and the Donald L. Scantlebury Memorial Award from the Joint Financial Management Improvement Program.

Mr. Jeffcoat is married to the former Elinore L. Higgins and has three children, Carlton, Sonya, and Meaghan.
