October CPE Luncheon — "Chasing Greatness"

The AGA Austin Chapter will host its October 2019 luncheon on October 10, 2019 at Pappadeaux Seafood Kitchen located at 11617 Research Boulevard, Austin, TX. Come meet Lieutenant James Thomas present 'Chasing Greatness.'

James Thomas began his career with the Texas Department of Public Safety (DPS) in 2001, attending the twentysix week training academy held in Austin, Texas. After graduating the academy in March 2002, he spent the next 9 ½ years in the Texas Highway Patrol. In April 2011, he joined the Texas Ranger Company "A" Special Response Team (SRT), a specialized team comprised of a cross section of officers from the Texas Highway Patrol, Criminal Investigations Division, and the Texas Rangers. SRT members are trained to conduct high risk warrant service and provide initial response to critical incidents. In October 2011, Thomas promoted to special agent with the DPS Criminal Investigations Division in Houston, where he served in the gang division. In April 2013, he was appointed as a Special Deputy United States Marshal with the United States Marshals Service Gulf Coast Violent Offenders and Fugitive Task Force. In May 2015, Thomas was promoted to Texas Ranger in El Paso, serving in Company "E". He currently serves as a lieutenant in the Texas Rangers and is stationed at the Company "F" headquarters in Waco. James holds a doctoral degree in Education Leadership from Lamar University in Beaumont, Texas. He earned a Master's degree in Behavioral Science from the University of Houston - Clear Lake. He also received a Bachelor's degree in Criminal Justice from Lamar University. His educational interests are related to studying the environmental factors impacting adolescent African American males. Thomas has held a basic TCOLE instructor license since 2004 and is a Master Peace Officer.

We kicked off the 2020 chapter year with a presentation from Ed Kelly, Chief Data Officer of Texas for the Department of Information Resources (DIR) on the Texas CDO Journey -Looking Back, Looking Forward. Ed begin his presentation with an overview of DIR's four primary services: Policy and Planning, Shared Technology Services, Bulk Purchasing, and Cooperative Contracts. He went on to discuss eligible DIR customers, which include 6,200+ local governments, 183 Texas State Agencies and Institutions of Higher Education and other organizations such as private schools, volunteer fire departments and even public entities outside of Texas. The Data Program was established in 2015 with House Bill 1912 in order to improve the control and security of information collected, promote the sharing of information between state agencies, reduce information collection costs, develop and implement best practices, among initiatives. Ed wrapped up his presentation with a discussion of some of the challenges of the program and its future.

State Pension Reform - Finding a Workable Solution

One of the largest budgetary issues that states across the country are dealing with is managing state pensions; namely in ensuring the longtime viability of these plans and the states' ability to meet all obligations. It is such a pervasive issue that in the past decade, 48 states—including Connecticut—have passed some form of state pension reform, according to published reports.

The truth is these pension plans, as they were created decades ago, are largely unworkable to-day. When they were created, such as here in Connecticut, it was simply easier on the state budget to make promises for later down the road than to reward employees at that time. But now, of course, we've reached that point "down the road," and once these liabilities are measured under requirements of the Government Accounting Standards Board (GASB), they are no longer affordable in their current form.

Those same published reports indicate that the majority of states that have engaged in some level of pension reform have modified their existing defined benefit (DB) pension plans, which provide recipients with steady monthly income for life. In most of these cases, plans have been altered for new hires to include things such as higher retirement ages, increased employee contributions and Cost of Living Adjustment (COLA) reductions for retirees and existing workers. These reports indicate that no states have yet shifted to a defined contribution (DC) plan (such as a 401(k)) since 2005, though several states have adopted a hybrid type of retirement arrangement that combines reduced DB pension benefits with a mandatory DC plan.

This is progress, but more needs to be done. And the single biggest issue standing in the way of

true pension reform involves working collaboratively with organized labor on an agreement. Without support of unions, true pension reform is unlikely to work.

Of the 48 states that engaged in some level of pension reform, roughly half of them faced legal challenges from unions, and that fact alone speaks directly to the problem. The success of the lawsuits have varied state to state—some have been upheld, others have been rejected and no steady pattern as to how to courts will handle them has emerged.

So rather than continue on the path of waiting for court-by-court decisions, a better approach could be to have a meaningful dialogue with union leaders to communicate that the current practice is unsustainable. Actions must be taken to preserve future benefits and address the structural issues, and if they are taken collaboratively with labor involvement, the chances of success are all the better. The issues that need to be addressed are:

- Increasing employee contributions;
- Creating a hybrid pension plan for new employees:
- Suspending/minimizing COLA adjustments; and.
- Raising vesting periods.

If done correctly, the benefits of such reform efforts could prove to be myriad. Taxpayers could see significant savings, retirees will see their long -term benefits preserved, and both current and future employees will have peace of mind in knowing their pension benefits are protected.

State pensions were created with the best intentions, but it happened long enough ago to outlive intended effectiveness. This is why a new approach is needed, in strict compliance with GASB, to ensure these problems don't linger for another generation. And, to ensure people who banked on these benefits all those years ago can still count on them.


