- Leases The GASB has issued Statement No. 87 Leases which dramatically changes the accounting for leases. The effective date is for reporting periods beginning after December 15, 2019. For more information and implementation guidance, see www.gasb.org.
- **Fiduciary Activities** The GASB has issued Statement No. 84 Fiduciary Activities which establishes criteria for identifying fiduciary activities of all state and local governments. The effective date is for reporting periods beginning after December 15, 2018. Earlier application is encouraged. For more information and implementation guidance, see www.gasb.org.
