

CEC minutes from the Fall Seminar and minutes for November 3, 2009, were approved.



Mark B. Kelton, a native of California, has been teaching at Evangel University in Springfield since 1985. Nominating Committee Announces Slate of Officers for 2010-2013

AGA's National Nominating Committee has selected its slate of officers to serve on the National Board of Directors for 2010-2013, with **Richard O. Bunce Jr., CGFM**, selected as National President-Elect Designate and **Amelia S. Leswing, CGFM, CPA, CISA**, chosen as National Treasurer-Elect Designate.

All nominees were selected unanimously and are subject to National Executive Committee and National Board of Directors approval. As outlined in <u>AGA's bylaws</u>, AGA will accept independent nominations from members via petition until Feb. 1, 2010. Send nominations to <u>AGA Executive Director Relmond Van Daniker</u>. If other candidates are nominated, the Bylaws and Procedures Committee will conduct an election to determine the officers.

However, if no other nominations are received, the committee's slate will take office at the Professional Development Conference & Exposition in Orlando July 11-14. The National President, National Treasurer and Regional Vice Presidents (RVPs) come on board as "elects" at that time. Senior Vice Presidents (SVPs) come on board in full capacity.

Bunce, a member of AGA's Richmond Chapter, is the executive director of Assurance Services at Virginia Commonwealth University. He has 32 years of experience in government accountability, including 11 years as a state legislative auditor and 21 years as the internal audit director at two major state agencies. An AGA Past National Treasurer, he has served as president of the Richmond Chapter and is the chair of AGA's Professional Certification Board.

Amelia Leswing, known as Mia, is a member of AGA's Northern Virginia Chapter. She is a partner with Clifton Gunderson with 28 years of experience in serving federal government agencies. She joined Clifton Gunderson in 1997 as a federal contracts manager and is considered an expert on federal regulations that affect the accounting and auditing industry. She has served as president of the Northern Virginia Chapter, among other leadership positions, and has been a Regional Vice President, Regional CGFM Coordinator and is a member of the AGA's Finance and Budget Committee.

Tax Tips - Roth IRA Conversion

Starting in 2010 and thereafter, you may convert all or part of a Traditional IRA into a Roth IRA regardless of your modified adjusted gross income (MAGI). Previously, such conversions could only be made if your MAGI was \$100,000 or less. You can also roll over assets from a previous employer's plan to a Roth IRA with no income limitations.

In addition, if you complete a Roth IRA conversion **during 2010**, you may choose to include the taxable portion of your conversion as 2010 income – or split the income equally between 2011 and 2012.

Using a Roth IRA can provide many advantages, including tax-free withdrawals in retirement, no required minimum distributions (RMDs), and estate planning benefits. A key consideration is whether to pay taxes now in order to provide tax-free income potential in the future. Learn how a Roth IRA compares with a Traditional IRA.


