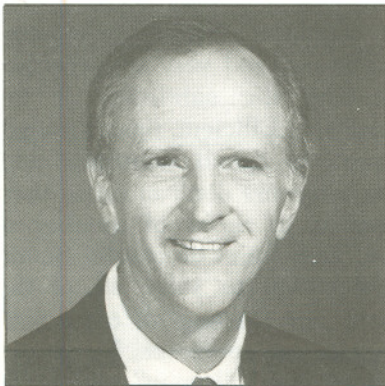

FEDERAL ACCOUNTING STANDARDS ADVISORY BOARD (FASAB) ANOTHER FIRST—HEARING THE PUBLIC

The FASAB scored another first on February 28, 1992, hearing testimony from a number of private sector experts, and others. Speakers included: Carol Cox Waite, President, Committee for a Responsible Federal Budget; Robert Anthony, Harvard University; Jesse Hughes, Old Dominion University/American Accounting Association; John Cherbini, Coopers and Lybrand; and American Institute of Certified Public Accountants representatives. The hearing highlighted many difficult issues facing the Board, e.g.

- (1) Is a conceptual framework document a necessary first step?
- (2) Should the Board adopt existing standards, e.g., Title II, or FASB?
- (3) Who will use the statements and for what purpose: Congress, public, Federal managers, or others?
- (4) Is a User Needs Study necessary?
- (5) Is Net Financial Resources a useful concept, and inclusions/exclusions?
- (6) What assets should be valued, esp. inventories and fixed assets, and how, acquisition cost, lower of cost or market, more than one way, or other?
- (7) Is depreciation a significant Federal financial management concept?
- (8) Are consolidated financial statements necessary, or are agency or program statements more appropriate?
- (9) Are there public/private sector differences significant to the Board's standard-setting activities?

Speakers and Board members supported a variety of solutions for issues raised, some directly opposed to each other. A single solution was not apparent for these and other issues.

PRESIDENT'S MESSAGE



Samuel T. Mok

As the CFO Act is in the process of implementation within all the Federal agencies, many financial managers face responsibility realignments and reporting line changes. Within every reorganization, there is an unfortunate yet inevitable perception of "winners" and "losers." Squeezing the best out of a not-very-happy situation is an important career management technique in these uncertain times. Job security, in the traditional sense, is a thing of the past even within the Federal employment sector as the government grapples with the National budget deficit. Working hard no longer determines career advancement. Rather, working smarter enhances the possibility of advancement during a downsizing climate. Doing the right thing right, the first time, every time, will be the solution to doing more with less.

In dealing with changes, a positive attitude toward life and a healthy dose of self-confidence are two important ingredients for successful career enhancement. I am a firm believer and practitioner of the old saying, "When God gives you a lemon, make lemonade and sell it for a profit." Temporary career setbacks are usually not fatal but can be at times a blessing in disguise. For example, reported recently by national newspapers, Gerald Levin was passed over for the top job at Time, Inc. a few years ago and ended up working for his career competitor, Nick Nicholas. Several weeks ago, while Nick was enjoying the ski slopes with his family, the Board of Directors of Time-Warner (the newly merged company from Time and Warner Brothers) forced out Mr. Nicholas; Mr. Levin is now the CEO heir apparent to a company several times larger than the one he was not allowed to manage. I have heard many similar "table turning" episodes in the Federal government. Just remember, when cream is mixed with water, water will not be able to stop the cream from rising. Be patient!

Working smarter requires efficient time management, sound prioritizations, and very sensitive political radar (understanding the subtleties of the politics in your organization). Efficient time management eliminates the need to spend unusually long hours in the office. True achievers don't measure their productivity or contribution in terms of number of hours spent in the office. They focus on results. Sound prioritization means not trying to solve all of the world's problems at once nor treating all tasks with equal urgency. A successful executive sets his or her priorities in terms of predefined "legacy" and holds everything else at neutral or break even. Decide how you wish to be remembered (legacy) and concentrate on tasks that will contribute toward that goal. Other priorities should be treated accordingly. Working without being plugged into a good political radar system is like driving on country roads in West Virginia blindfolded. There are many ways to "plug in." Being active in professional organizations such as AGA is a proven method. Be active!

Sometimes, leaving is the best change. My career has received a substantial boost every time I made a change by leaving. I must admit that it was very scary and extremely risky when taking those steps. Each time, I suffered through many sleepless nights before finally making the "jump." In hindsight, I am glad I did or I would still be miserable and spending time wondering "what if." It takes a lot of courage and family support to take career risks. But if done correctly, the reward is well worth it. Be brave!

Bottom line—do the best you can, maintain a positive attitude, be patient, be active, be brave, keep all options open and don't be boxed in!

ABOUT THE SPEAKER

Stephen A. Trodden was confirmed by the Senate on August 4, 1990, following his nomination by President Bush to be the Inspector General for the Department of Veterans Affairs.

As VA Inspector General, Mr. Trodden directs a nationwide staff of some 417 investigative and audit personnel. His office conducts oversight reviews to find ways to enhance the effectiveness and efficiency of VA programs, and to prevent waste, abuse and fraud.

In 1986, Mr. Trodden was selected to be the Assistant Inspector General for Auditing in the Office of the Inspector General, Department of Defense, where he was the Director for Major Acquisition Programs from 1983 to 1986. He was the Director for Procurement in the Office of the Assistant Secretary of Defense (Comptroller) from 1981 to 1983, and the Deputy Director from 1975 to 1981. From 1973 to 1975, he was the Deputy Director for Research and Development in the office of the Assistant Secretary of Defense (Comptroller). He served as Technical Advisor/Budget Analyst in the Directorate for Procurement, Office of the Assistant Secretary of Defense (Comptroller) from 1969 to 1973. From 1966 to 1969, Mr. Trodden was Staff Officer for the REDEYE and SAM-D missile systems, U.S. Army Missile Command, and from 1962 to 1966 he was an industrial engineer with the U.S. Army Material Command.

Mr. Trodden was appointed to the Senior Executive Service in 1979. In 1983, he was awarded the Secretary of Defense Meritorious Civilian Service Award for developing budget policies and financial management principles for multi-year procurement contracting. In 1990, he received the Secretary of Defense Distinguished Civilian Service Award for making significant contributions to detecting and preventing fraud, waste, and mismanagement, and to improving the economy and effectiveness of DoD policies, procedures and programs.

Mr. Trodden is a graduate of the University of Michigan (B.S.E., 1962) and the Georgetown University Law Center (J.D., 1965).

A Washington, D.C. native, Mr. Trodden is married, has two children, and resides in Arlington, Va.

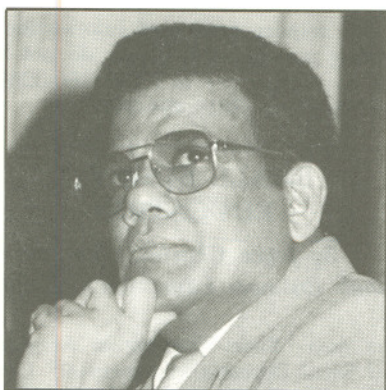

WASHINGTON CHAPTER Minutes for February 26, 1992 Meeting of CEC.

Call to Order: Secretary Pat Wensel called the meeting to order at 11:45 am.

Secretary's Report: The secretary's report was approved as presented. All members present thought it was good to receive copies of the minutes prior to the meeting.

Treasurer's Report: The treasurer's report as of February 12, 1992 was mailed to all board members for review prior to the CEC meeting. Warren Cottingham reported that for the upcoming two day educational event in April, we need an attendance of 260 to meet our profit goal and 120 to break even. ASMC owes the Chapter \$3,394.64 from the joint educational event held in January. The treasurer and Chapter President are both working with ASMC to collect the amount. (Note: Subsequent to the CEC meeting, a check was received from ASMC in full payment.) The treasurer's report was accepted as presented.

Committee Reports:

Regional News—Doris Chew, reported that Bill Sharkey has resigned as our representative to the National Executive Council. Joe Donlon was appointed as the new representative to the NEC. A meeting was held with Neil Tierney, Chair of the Education and Research Foundation. He realizes that educational events by the foundation are providing substantial competition to our educational events and draining training dollars available in the D.C. area. It was proposed that the foundation share revenues from their events with local chapters at a rate of \$10 per head for chapter members attending locally held national events. The CEC voted to accept this proposal.

Program—President Mok reported that a speaker is needed for April. Mayor Kelly declined due to a prior commitment.

Meetings—Judy Parsons reported that we had 106 for the February luncheon meeting and 37 attended the seminar. The March meeting will be held at the Marriott Hotel at 1221 L Street, N.W. Helene Boatner, Comptroller, CIA, will be the speaker.

Education—Mike Noble reported that the 2 day seminar is scheduled for April 15 and 16 at the Ramada Tech World on 9th Street, N.W. Maximum capacity for the event is 300 at a cost of \$240 for both days to include coffee breaks and lunch. Jill Kent, CFO at State, and Neil Tierney, Chair of AGA National Education and Research Foundation, will be keynote speakers. The first day will focus on accounting systems, while the second day will address form and content of financial statement, preparing for audit, Systems 90, and the new auditing guidelines.

Publicity/Agency Liaison—Karl Boetcher reported that he is finalizing the list of agency contacts. Deputy CFOs of agencies have been particularly supportive in those efforts. The committee is developing a marketing plan to get news of events to the agency contacts. Dennis Mitchell has developed a mailing list of CFOs and Deputy CFOs and offered to provide labels to Karl. Dennis will request an extra set of labels from National for Mike Noble to send a special flyer on the April event. There will be a social activity event at the Touchdown Club on March 18. It is publicized in the current newsletter.

Chapter Awards—Neil Davies reported that March 6 is the due date for award nominations to National. All nominations are due to Nancy Fleetwood by February 28.

Research—Marc Page has split the committee into three teams. Objectives have been developed for each team. A listing of the team members with their objective was distributed. Marc continues to receive calls from others who want to serve. He has formed a waiting list and is encouraging callers to join other committees.

Small Business—Joyce Charles reported that the small business course is scheduled to begin in April at the Department of Labor. The fee will be \$50 per registrant. The textbook is being revised - errors had been found. Joyce inquired about a bulk mail permit. The Chapter does not have a bulk permit.

President Mok reported that a reporter from the Washington Times called to research a complaint about the speech delivered by Dr. Nichols at the Leadership Conference. A negative article may result. Dianne Guensberg was appointed to the vacant directorship on the board with unanimous approval by the board. A nominating committee will be appointed by President Mok. A new committee has been appointed for the purpose of organizing activities and social events. A name will be determined at a later date.

President Mok adjourned the meeting at 12:58 p.m. The next CEC meeting will be held on March 25.
