News from National/NCC Rep

Hello, everyone!

As governments wrap up the year-end and start preparing their Comprehensive Annual Financial Reports (CAFRs), many also issue Popular Annual Financial Reports (PAFRs) to communicate results to their citizens in a less technical and more user-friendly format. They focus on the flow of resources to the government, how those resources were used and the results that were achieved with those resources.

In an effort to make government spending more transparent and easier to understand, the National AGA office developed the Citizen-Centric Report (CCR) reporting style in 2007, and since then, over 400 government CCRs have been published to provide citizens a clear and concise understanding of where taxpayer dollars are going.

The CCR is a 4 page report format that uses charts, tables and graphics to share useful information on a government's annual financial and operating results. You will see

- a description of the agency and its mission (page 1),
- service and performance metrics and outcomes (page 2),
- financial revenues and expenditures (page 3), and
- upcoming challenges and goals that the entity has in the future (page 4).

The National AGA office and its Chapters use a similar format, the Member-Centric Report, to highlight key information to keep members informed on their annual results and achievements.

Did you know that your Ozarks AGA Chapter produces a Member-Centric Report in the fall? You can find those on the Chapter website. Your Chapter Executive Committee is currently working on our annual report for the 2019-2020 reporting year. We expect to have that report published in early November.

I will update you next month with more news from National.



Why the CGFM?

Q: What prompted you to begin the process of obtaining your CGFM?

A: From the first time I heard of it, I was really intrigued and I wanted to do it, but was too intimidated. A coworker at the City said she wanted to pursue it so we decided to do it together.

Q: How has it helped your confidence?

A: It was a tremendous help with my confidence and it wasn't necessarily what I learned, but just knowing I completed it. There is great satisfaction in finishing something challenging.

Q: How do you feel it has helped you in performing your job duties?

A: The continuing education definitely helps me in my job duties. Staying on top of changes keeps me informed.

Q: What did you find helpful in studying for the CGFM Certification?

A: Having someone do it with me was the thing that got me through. I couldn't let her down. I would HIGHLY recommend asking a co-worker if they are interested in the CGFM, you might be surprised!

Q: What would you suggest to candidates to help them pass the exams?

A: When I took it, the practice questions in the guide weren't anything like the real questions. You have to be able to take all the concepts and apply them. DON'T second guess the instinct you have on your first answer to a question.

Q: What resources did you use to help prepare?

A: I used the study guides. We ACTUALLY went to Washington DC for two of the three training sessions at National AGA. It wasn't really necessary



because they kind of just read the book to you.

Q: Did you know that Ozarks Chapter will reimburse you for the application and exams once all exams have been passed if your employer has not paid for them?

A: Yes! I think I helped implement that policy. I think it's a great opportunity for those that have to pay for it themselves.

Q: How long did it take you from when you started the application process to complete the certification process?

A: We really got aggressive about passing the exams when we got back. We met once or twice a week to study together "presenting" a chapter of the study guide to each other at a time. We tackled the hardest book first so we wouldn't forget it. We took that first exam 4 to 6 weeks after returning and we both passed, then we studies the next book and a month later took that test, then the third. I don't remember the application process time but from the time we went to DC to passing the last exam was five really intense months! Not sure if I would recommend it but there is no way I could have done that schedule alone.
