Political Reactions to the Gasoline Price Hikes

It has often been suggested that one solution to the US energy crisis might be the capture of hot air generated in Washington when there is a problem for which there are no easy solutions and plenty of opinions. The dramatic rise in gas prices have brought out the political commentary in force. Calls for the opening of the Arctic National Wildlife Refuge have been sounded again. Its opening would do nothing for oil supply for years and at best it would provide a million barrels a day (the US consumes over 21 million barrels a day). President Bush suggested that not building a refinery in 30 years might have something to do with the current problem and Dick Durbin of Chicago shot back that refineries are only producing at 83% so capacity can't be the issue. It should be pointed out to the Congressmen that refineries ran at close to 96% capacity all last year and that they are only down to 83% this year because demand is off and they are trying to avoid buying high cost crude. There are suggestions that oil companies be taxed more or that they should be made to pay fuel taxes (as if these would not be passed on to the consumer). In other words, this is silly season again.

Analysis: There is certainly an expectation that the elected officials should be engaged in finding solutions for major problems that affect their constituents but what can be so maddening is that it appears that most of them have just noticed that there is an issue and that there has been nothing that could have been done in the past to deal with this. It was only this year that fuel efficiency standards were adjusted and there is still little attention to alternatives to the private car. Europe has dealt with gas prices at this level for years but the average person has mass transit alternatives – not something available to over 86% of the US population. Perhaps now would be a good time to look at the transportation and fuel issue in a more comprehensive manner – just a thought.

Relief for Stimulus Payments Withdrawn from IRAs and Tax-Favored Accounts



Issue Number: IR-2008-068
WASHINGTON — Economic stimulus payments directly deposited into IRAs and other tax-favored accounts may be withdrawn tax-free and penalty-free, the Internal Revenue Service announced today.

This relief is designed to help taxpayers who may have been unaware that by choosing direct deposit for their entire regular tax refund, they were also choosing to have their stimulus payment directly deposited as well. If a taxpayer elected a split refund, however, their stimulus payment will be paid by a paper check.

This relief is available for amounts withdrawn from these tax-favored accounts that are less than or equal to a taxpayer's directly deposited stimulus payment.

To qualify for this relief, funds must be taken out by

April 15, 2009, in most cases. Without this relief, taxes, penalties and other special rules would apply to amounts removed from these accounts. Regular refunds are not eligible for this relief.

Eligible tax-favored accounts include traditional and Roth IRAs, health savings accounts (HSAs), Archer MSAs, Coverdell education savings accounts (ESAs) and qualified tuition programs, also known as QTPs or 529 plans. Thus, for example, a taxpayer whose \$1,200 stimulus payment is directly deposited into his or her IRA can take out anywhere up to \$1,200 from the IRA, tax-free and penalty-free.

In general, the deadline for these withdrawals is the due date or extended due date for filing a 2008 return. This means April 15, 2009, for most taxpayers, or Oct. 15, 2009, for those who obtain tax-filing extensions.

Details on reporting these withdrawals and claiming relief will be included in tax forms and instructions for 2008. Other details are in <u>Announcement 2008-44</u> on the IRS web site.

Do You Need to Work Faster? Get a Bigger Computer Monitor

University of Utah researchers recently investigated how rapidly individuals did such jobs as editing an item and copying figures between spreadsheets while utilizing various computer configurations--one with an 18-inch monitor, a screen with a two-foot monitor, and one with a pair of 20-inch monitors.

They discovered that individuals employing the two-foot screen finished their jobs 52 percent quicker than people who utilized the 18-inch monitors, while workers who employed the pair of 20-inch monitors were 44 percent faster than employees with the 18-inch screens.

The study determined that somebody using a bigger monitor could save 2.5 hours each day. James Anderson, who headed the study, notes that this is assuming an employee will work for eight hours straight, and that the jobs they do will benefit from a bigger screen, which is not

always so. Jobs such as moving information between files, however, are well-suited to large or several screens. Anderson suggests that companies match workers with the correct screen size based on job mandates. The study was financed by NEC Corp.

The Real Reason Employees Leave, and How to Keep The Best

Why do people leave teams and organizations? The No. 1 reason people leave jobs is because they fail to connect with their bosses as leaders and as people. People are rarely honest about why they leave a company. Too many associates that depart follow Jimmy Conway's advice (played by Robert DeNiro) in the 1990 hit movie "Goodfellas," who told Henry Hill (played by Ray Liotta), "Never rat on your friends and keep your mouth shut." There is no upside incentive for the employee to be open and honest. The primary reason people leave

companies is because of the relationship and lack of emotional connection with their boss. However, it is almost never talked about in the exit interview. Why? Who wants to burn a bridge with a boss they may need for a future job reference? – – Jim Welch, *AccountingWEB*
