#### **Dave Gandule and Deyandra Abella**

The PDT AGA event took place this year in Orlando, Florida. The event took place from July 23 – 26, 2023. The organizers were able to successfully hold the PDT 2023 AGA event in person in Orlando, Florida, post pandemic. This allowed participants to once again benefit from the outstanding educational sessions, seminars, and speakers, and to engage with colleagues and peers in building their professional network. The event provided a valuable opportunity for attendees to invigorate their minds, enhance their personal journey, and continue their learning and growth after the challenges posed by the pandemic.



Here is a summary of what we learned from the sessions we attended:

In Session #S104, Eric Gregory presented "Followership: The Training You've Never Had," discussing the crucial role of followers in realizing a leader's vision. He emphasized key skills such as supporting and challenging leaders when necessary, fostering good relationships, and having the courage to exercise influence. Eric highlighted the evolution from follower to leader and the significance of advocating for leaders, contributing to their growth and overall organizational success.

During Session #S110, speakers Mark Reger CPA, Frank Petersen CGFM, and Melinda Miguel PMP, CIG explored the presentation "Your Boss Presents You with an Ethical Challenge: Fight or Flee." Mark highlighted the enduring impact of ethical decisions on reputation, while Melinda underscored the need for a support network when facing ethical challenges. Frank emphasized the duty to safeguard public trust, stressing personal values and strong character as essential for ethical leadership.

During Session #M101, speaker Alex Weber delivered a presentation titled "Unstoppable". Alex emphasized that individual actions hold significance and promoted the cultivation of positive energy. The talk focused on keys to becoming unstoppable: having clarity with courage in goals, aligning with a meaningful cause, possessing self-confidence, and



building a supportive community. Alex also highlighted how challenges contribute to personal growth by fostering empathy and the ability to shine when others require assistance.

During Session #M105, speakers Alyssa Smiley, Jeremy Stone, and Nicole Frish addressed the topic "Maximize Your Potential Against Improper Payments." Alyssa Smiley discussed the DHS's focus on payment integrity and risk management, emphasizing the importance of defining and quantifying payment integrity, as well as establishing tolerance levels. Jeremy Stone highlighted using regulations and laws strategically for efficient payment integrity in DOD programs, suggesting breaking down programs for detailed risk analysis. Nicole Frish discussed the Department of Veterans Affairs' approach to minimizing improper payments,

emphasizing deep cause analysis, post-correction evaluation, and program ownership oversight. The session explored strategies to combat improper payments while considering risk tolerance and program intricacies.

During Session #M111, Gerry Boaz and Kimberly Fix talked about the new lease standards in their presentation titled "Applying State & Local Lessons Learned to the Federal Government." Gerry covered the contrasts between GASB 87 and SFFAS 54 lease standards, focusing on lease criteria and challenges like amortization. Kimberly highlighted the importance of good preparation for SFFAS 54, including policy review, teamwork, and supporting operations. The session touched on practical aspects of implementing these standards, like system changes, dealing with recurring payments, and coordinating with auditors. Attendees gained valuable insights into navigating the transition to new lease standards.




During Session #M121, "A State of Flux - What's Going on with the Accounting Profession?," Christine Kuglin, Billy Morehead, and Rachelle Cabading addressed shifts in the accounting landscape. Christine highlighted changing educational trends, with women pursuing higher degrees and men leaning towards blue-collar fields. Rachelle pointed out the evolution of the CPA profession, particularly in government roles, highlighting issues like vague job descriptions, lack of awareness about government positions, and uncompetitive compensation. Billy discussed key drivers for industry changes

including technology, more attractive career options, and the changing ROI of becoming a CPA. The session offered a comprehensive exploration of challenges and opportunities in accounting.

In Session #M128, Jennifer Franks, Ronda Kent, and Stacy Marcott explored "Leading the Future - Women in Government." They discussed shifts in workplace dynamics for women, highlighting increased flexibility, a focus on output rather than appearance, and the importance of embracing differences. The speakers emphasized finding support through strategic positioning and building positive relationships, underlining continuous learning opportunities. They also touched on the challenges and experiences of women in the male-dominated field of cybersecurity, shedding light on gender dynamics within teams.

During Plenary Session #T101, Gene Dodaro and Dave Lebryk discussed updates from GAO and Treasury. They covered topics like clarifying roles in public health, addressing improper payments, adapting to a changing budget environment, and embracing emerging technologies. The speakers also shared key lessons, including the need to manage the debt ceiling more effectively, promote employee engagement, and create a flexible yet cohesive work culture.

In Session #T107, Carla Flores and Taka Ariga explored the journey from "Ex Machina to ChatGPT" in the Information Technology-Technical field. They discussed the nuances of generative vs. general AI and how AI impacts our lives, highlighting efficiency improvements and potential job displacement. The session underlined the need to manage AI as a collaborative effort, addressing governance, data, performance, and monitoring to ensure responsible AI deployment. The presentation emphasized the balance between AI's opportunities and associated risks.



In Session #T113, Frank Petersen, Shelia Conley, and Stacy Marcott tackled "Leadership Challenges in Financial Management." They discussed IT modernization's role in financial processes and AI, emphasizing the need for foundational



strength and risk mitigation. Workforce development strategies were explored, focusing on motivating staff through higher purpose and team growth, as well as individual development plans. The session also addressed the challenge of coaching staff within daily operations, emphasizing the importance of prioritizing people and taking ownership of one's career path.

In Session #W109, "Transformative Leadership at Work: Highlights of the Cohort Capstones" the members from the cohort shared their experiences from this year's AGA NextWave Federal Finance Leadership Program's capstone project. The members discussed items such as management program's benefits, self-improvement strategies, and the impact of AI in innovative projects. The focus was on personal growth, understanding personalities, and preparing young professionals for federal executive roles. The session also emphasized the significance of contributing to the growth of young leaders as executive members.

In Session #W117, Kim Farington, Teresa Hunter, and Vinay Singh explored the theme "Individual Strengths Improve Team Performance" in the context of Personal Development. Kim highlighted strategies for building strong teams by identifying and utilizing individual strengths. Teresa discussed reimagining the IRS CFO role with a shift towards agility and innovation. Vinay emphasized effective individual management through measurement, kindness, quick solutions, and team clarity. They also addressed managing unhappy employees with strategies focused on engagement and empathy. The session underscored the significance of leveraging strengths for improved team dynamics, innovation, and effective management.

In Session #W120, Childilim Okonkwo, Craig Fischer, David Dalenberg, and Kate Darling tackled the topic "Do Your Decisions Reflect Your Data or Vice Versa." They explored using data analytics and Key Performance Indicators (KPIs) to gauge mission effectiveness, highlighted the value of mission-centric dashboards, and emphasized strategy building and tool understanding for informed decision-making. The session emphasized clear messaging and appropriate data visualization, along with the importance of foundational training before implementing digital science approaches.

As the event concluded, it left participants with a renewed sense of purpose, a wider perspective on challenges and opportunities, and a strengthened resolve to navigate the complex landscapes of their respective fields. The PDT AGA event of 2023 in Orlando, Florida, not only marked a return to normalcy but also served as a catalyst for continuous growth, learning, and the building of meaningful connections among professionals committed to excellence.
