Government	Individuals who work directly for government, academia and not-for-profit organizations. Individuals employed by a private entity as a contractor for a government agency, even if they report to a government-owned property, are considered Private Sector professionals for AGA membership. \$100/year.
Private Sector	Sole proprietors and individuals who work for private companies, corporations or partnerships. \$160/year.
Young Professional	Professionals with fewer than three years of any work experience. \$45/year.
Student	Full-time college or university students who are not gainfully employed. Free Electronic Membership.
Retired	Current AGA members who have permanently retired from government, academia, not-for-profit or commercial enterprises or ventures. \$35/year
Lifetime - Free	Lifetime membership is bestowed upon individuals who have maintained active member status for 40 consecutive years, to recognize their distinguished service to AGA. Lifetime memberships are awarded each lanuary
