



Kenneth E. Carfine



Biography

Ken Carfine was appointed Fiscal Assistant Secretary, a career position, on March 15, 2007.

In this position, Mr. Carfine provides policy oversight over the two Fiscal Service Bureaus -- the Financial Management

Service and the Bureau of the Public Debt. This office also serves as the Treasury's liaison with the Federal Reserve System in its role as the government's fiscal agent. The scope of his responsibilities includes managing the government's cash flow, improving government financial management, executing the government's financing activities and overseeing the operation of government-wide financial accounting and reporting systems, including the preparation of the Consolidated Financial Statements of the United States. In addition, Mr. Carfine is a statutory member of the Governmentwide CFO Council, and represents the Secretary on the Trust Fund Boards for the National Archives and Library of Congress.

Previously, Mr. Carfine was the Deputy Assistant Secretary for Fiscal Operations and Policy, a position to which he was appointed in April 2003. In that position, he advised and assisted the Fiscal Assistant Secretary on a broad range of policy and operational matters related to the fiscal activities of the Treasury, and oversaw the development and implementation of policies relating to the government's cash and investment management, debt financing, trust fund investment and administration, payments, collections and debt collection. He also worked closely with the Financial Management Service, the Bureau of the Public Debt, and the Federal Reserve System in the execution of his duties.

Mr. Carfine began his Treasury career in 1973 with the Financial Management Service, holding positions of increasing responsibility in areas of banking, cash management, payments, check claims, and governmentwide accounting.

Mr. Carfine graduated from the University of Baltimore with a B.S. degree in Accounting. He and his wife, Deborah, have two sons and one granddaughter and live in Maryland.



Inside the Black Box by Simcha Kuritzky, CGFM CPA



Appropriation Corrections in the Journal and on the FMS-224

With continuing resolutions lasting longer and longer, many agencies get taken by surprise when the appropriation finally gets passed. Not only do the amounts vary, but the funding structure itself may be very different from what they had anticipated and, more importantly, loaded into their financial system. What can you do if you thought your funding would come in on a single-year fund but Congress moved it to a multi-year fund? I will give two possible scenarios. It is important to note, though, that making the change in your agency's accounting system may not be sufficient; there may also need to be special postings to fix Treasury's records on their cash balance statement (FMS-6653). For those agencies already using the Governmentwide Accounting (GWA) system, there may be alternative remedies.

Set Up

Agency X was anticipating a \$1.1 billion appropriation in their fund number 6. This fund has always been a single-year fund. With the continuing resolution in place for two months, the agency set up fund 6 for 2009 with symbol 9990006 and anticipated a warrant for \$1100M. Payroll disbursements, which are reported by Agency Y, were \$100M and Agency X disbursed another \$50M in 9990006. The appropriation was actually for \$900M in a new multi-year fund, 999/00006. The starting value of the agency's and Treasury's books follows. I show disbursements as a reduction to cash and not an increase in disbursements for ease of comparison to journal balances. All the non-cash accounts are lumped into one entry because they aren't relevant to the discussion; though they are included so debits will equal credits. This example also assumes that any postings to cash account 1010D will be reported on the agency's FMS-224 Statement of Transactions, while postings to all other cash accounts listed here won't.

Solution #1 - Transfer

One solution is to set up a new fund, 6M, for the multi-year. All the postings that had been in fund 6 are backed out and reposted to 6M. This will result in correct FACTS and FACTS II trial balance submissions, but will not correct all the activity already reported to FMS. The amounts reported by the payroll-processing agency have to be transferred to the correct symbol by the agency using the normal disbursements account, so they are reported on the FMS-224. This means that, in addition to transferring the cash, the agency must post debit 1010D credit 1010P the \$100M of payroll, to back it out of the single-year fund on the FMS-224 (the opposite is posted into the multi-year fund).

In this way, the agency has \$100M of payroll disbursements in the single-year fund, which agrees to what was reported on the Agency Y's FMS-224. However, there is an offset reduction of \$100M disbursements under the Agency X's own Agency Location Code (ALC), so the net cash balance is zero. The disbursement shows up under the Agency X's ALC in the multi-year fund.

Any future payroll postings that use the incorrect single-year appropriation will have to be entered into fund 6M as an agency disbursement (using account 1010D), and only a transfer entry of debit 1010D credit 1010P should be made to fund 6.

Solution #2 – Retroactive Adjustment

Another solution is to force the original Fund 6 to use the multi-year symbol. All the postings that had been in Fund 6 are changed to show symbol 999/00006. This will result in correct FACTS and FACTS II trial balance submissions, but will not correct all the activity already reported to Treasury. The amounts reported by both agencies X and Y have to be transferred to the correct symbol on the FMS-224 (by posting the normal disbursements account). This means that the agency must post debit 1010D the \$150 million of payroll and other disbursements to back them out of the single-year fund on the FMS-224, and post the opposite into the multi-year fund. How this is accomplished will depend on the system. We will assume they back out the postings with the old symbol, then adjust their journals (but not the FMS-224) to show the new symbol, then post the other side of the adjustment entry.

Since Agency X has no fund with the single-year symbol any more, there is no place to represent the \$100 million of payroll disbursements in the single-year fund. However, the net value of zero (if you include both ALCs from Treasury's statements) does agree with the agency's revised books (which shows nothing under the single-year symbol).

Any future payroll postings that use the incorrect single-year appropriation will have to be entered into Fund 6 as an agency disbursement (using account 1010D) with the multi-year symbol, and a transfer entry needs to be made (how is dependent on the system) to reduce the disbursement under the single-year appropriation symbol. If this is not easily done, the agency may have to wait until Agency Y updates its records before correcting the symbol in its journals.



Federal CFOs could be key players in Obama administration

Chief financial officers could play a significant role in shaping agency missions during the next administration. But first, they'll need to learn the ins and outs of federal financial management, which is very different than in the private sector, where most incoming CFOs are likely to have been schooled.

"President-elect Obama has talked about wanting to bring a scalpel to programs and to really look at places in the federal government where we can take money from certain things that are no longer effective and apply it to other things," said Patricia Healy, who served nine years as deputy chief financial officer at the Agriculture Department before retiring from federal service in January 2008.

"CFOs should be on the strategic executive teams, working with the missions and doing that analytic work to determine how the programs can operate more effectively, how we can work across government agencies more effectively," said Healy, now an executive consultant at CGI Federal.

To help bring incoming CFOs up to speed, Healy led a group of current and former federal executives working as advisers to the Council for Excellence in Government, a nonprofit organization in Washington that works to improve public sector management, to produce the "Federal CFO Roadmap." The five-page document outlines the responsibilities of finance personnel and the key laws that govern reporting and accountability requirements.

"The audience for this is really the incoming appointees, so they understand the full scope of the job in the federal government," Healy said. The document describes the federal budget process, major reporting milestones CFOs must meet, and a dozen laws that govern the process.

Healy advised incoming CFOs to read the laws behind their responsibilities and develop strong partnerships with career personnel who can help them navigate the requirements.

"This is the time for the CFOs to really become involved with their agency's missions," she said. "There's not going to be new money. We're going to have to make do with what we have and we're going to have to use it in the best way."
