

# Meet AGA's Next National President William D. Miller, CGFM, CIA

#### Please tell AGA members how your membership has affected your professional life.

I am a firm believer that AGA had a lot to do with my professional life. Leadership opportunities within the chapter, region and then further up to the national level, set the stage for leadership in the workplace. It took a little time before I volunteered to lead; but once I did, I saw value from both an organizational and a professional workplace standpoint. I served three chapters in different geographic locations, as well as made professional moves out of my home geographic area and learned how to lead in different environments. I reached high-level professional positions of which I attribute much of that success to the leadership roles that I encountered within AGA over the years.

#### What do you see as AGA's greatest challenge and where do you think AGA can and should impact?

While I think AGA does an excellent job in membership — in both member value and numbers, we can do much better. AGA offers excellent training and a first-class certification program — the Certified Government Financial Manager (CGFM). In its first 20 years, the CGFM program has grown, but more needs to be done. The key to the certification program is recognizing and showing the value of the CGFM. AGA represents all levels of government and the private sector. We should be able to substantially increase the number of CGFMs. As many know, when you advance in your career and move toward obtaining management positions, the CGFM credential offers a valuable competitive advantage. Oftentimes, when vying for a leadership position, certification is required of applicants. We know the value of CGFM for government employees; and our hope is that CGFM

becomes the standard. The CGFM is the best-suited certification for government financial professionals.

## Where do you plan to put the most emphasis in the coming year?

Programmatically, I will stress membership and CGFM certification. And, I will continue supporting and promoting the accountability initiative. I will work with the new Executive Director, continuing to promote and build on the proud accomplishments we have achieved and focus our vision for the future. I will be a spokesperson for AGA's organizational greatness.

## What are you most looking forward to as National President?

As National President, I will be just one of many who make AGA a successful and highly-professional organization. I look forward to the collaboration with all of our members and corporate partners in developing programs and promoting leadership
