January's Secretary Report

The January meeting of the East TN AGA Chapter was held on January 11, 2022, held virtually and in-person at Calhoun's on the River. President Travis Lowe opened the meeting and invited those in attendance to the lunch buffet. Mr. Lowe then introduced our speakers, Nathan Woods and Sam Paganelli, from Rather and Kittrell. Mr. Woods was on site at Calhoun's while Mr. Paganelli presented virtually.

Mr. Woods opened with a brief history of Rather and Kittrell mentioning that they were founded in May 2000 with two employees. They now have 36 team members and have served more than 800 families for in depth financial planning. He then discussed charitable contribution strategies used to avoid certain taxes. Donor advised funds and qualified charitable distributions are two recommended approaches. He followed this with a quick retirement plan benchmarking discussion.

Mr. Woods then introduced Sam Paganelli. Mr. Paganelli discussed behavioral finance and how human emotions can hurt investment performance. Investors tend to overreact with market changes and sell or buy at the worst possible times. He then discussed how investment advisors can help the investor stay on track with their investment goals and keep their emotions out of decision making.

After the presentation, President Lowe announced how the Chapter met our matching pledge goal from the December meeting of \$1,500 for KARM. He thanked everyone for attending and then closed the meeting.

Kelley McNeal is a CCFO Training Consultant with the University of Tennessee (UT) County Technical Assistance Service (CTAS). CTAS is an agency of the UT Institute for Public Service. The CCFO (County Certified Finance Officer) is a program that provides Tennessee's county financial officers an opportunity to learn about accounting and financial reporting principles and enhance their skills in order to carry out their responsibilities for the fiscal affairs of their county or department. CTAS administers the educational program and testing to achieve the CCFO designation certified by the Comptroller of the Treasury.

Prior to joining CTAS in July 2018, Kelley worked as an Information Systems Auditor with the Comptroller of the Treasury's Division of Local Government Audit for 23 years. During her time with the Comptroller's office, Kelley performed information system reviews in conjunction with financial audits in 23 counties in the Upper Cumberland and Sequatchie Valley areas of state.

Kelley holds a Bachelor of Business Administration in Accounting and a Master of Business Administration with an accounting concentration from Tennessee Technological University.

She has served as an adjunct faculty member at Nashville State Community College in Cookeville and Tennessee Technological University. Kelley is a Certified Public Accountant, Certified Government Financial Manager and Certified Professional in Training Management. She is a member of the AGA, TSCPA, AICPA, and TGFOA.

Kelley is a Paul Harris Fellow and charter member of the Rotary Club of Cookeville – Sunset. She has served as the PR Director, Vice President, President, and is currently the Past-President.
