

"RECENT THOUGHTS ON EFFICIENCIES IN GOVERNMENT FINANCIAL MANAGEMENT SYSTEMS"

As the Deputy Chief Financial Officer and Director for Financial Management of the Department of Commerce, Mr. Clyde G. McShan is responsible for financial management and accounting activities throughout the Department. Included in these responsibilities is the development of an integrated financial management system for all Department bureaus and offices.

Mr. McShan was Director of the U.S. Department of Agriculture's National Finance Center (NFC) in New Orlean, LA, from 1981 until 1993. A career employee of USDA, Mr. McShan began his Federal service in 1965 as an auditor with the Office of the Inspector General. He joined the staff of the NFC in 1972 and held several managerial positions before being appointed Director.

Under Mr. McShan's direction, the NFC became a recognized leader in providing financial management services to the Federal sector. His achievements have been recognized by the Department of Agriculture's highest award, the Distinguished Service Award, a Distinguished Executive Service Award from the Senior Executive Association, and a Presidential Meritorious Rank Award. He has been named one of the top 100 Federal information systems managers by Federal Computer Week. In 1993 he received the Elmer Staats Award from the Association of Government Accountants which is presented for outstanding executive leadership in the area of financial management.

A native of New Orleans, Mr. McShan is a graduate of Southeastern Louisiana University with a B.A. degree in accounting. He was recently nominated as AGA's National President-Elect. He has earned the professional disignations of Certified Office Automation Professional.

SUMMARY OF LUNCHEON SPEECH

Our speaker for the March 4, 1993 luncheon meeting was Mr. Mark Chastang, Executive Director, D.C. General Hospital. Mr. Chastang spoke on the impact of health care reform on public hospitals. D.C. General Hospital is the only public hospital in the city of Washington, D.C., a city in the "midst of a serious health care crisis" (AIDS, gun shot wounds, stabbings, and drug abuse). Mr. Chastang highlighted some very interesting and disturbing statistics about D.C. health care and nationwide health care:

- 25% of D.C. residents are uninsured;
- approximately 12,000 are incarcerated in public correctional institutions;
- 1 in 5 new mothers abuse drugs;
- D.C. has a large homeless population;
- D.C. General Hospital has the busiest trauma unit in the city (In 1991, there were 106,000 outpatient visits, 15,000 admissions, and 83,000 emergency room visits); and
- D.C. General Hospital provides quality health care regardless of ability to pay.

According to Mr. Chastang, health care costs are out of control in this country. \$1 in every \$7 of the GNP goes for health care costs. There are 38 million uninsured people in this country, of which 30 million are employed - 54% full-time and full-year.

Mr. Chastang asked the question: "Is quality health care a right of all Americans?" He quoted results of survey that concluded that most Americans want quality health care for all, but only 35% are willing to pay for it.

Mr. Chastang discussed some of the reasons for the rise in health care costs. He concluded that health care costs are driven by the supply of physicians. The rise in the number of physicians in the United States and the increasing number of subspecialists are the contributing factors. Life style drives infant mortality rates higher. Also, many of the uninsured are predisposed to high health care costs by their life style. Many do not eat right, or live in an unhealthy environment. Providing quality health care for these individuals will cause costs to escalate straight up.

According to Mr. Chastang, the United States has some of the highest spendings for health care costs, yet there is a high dissatisfaction factor. We have the best quality and most readily available health care in the world. We have the most advanced technology. He pointed out that there are different values in other countries as to the priorities for health care. There are long waiting periods for elective surgery and sophisticated tests, i.e., CAT scans and MRIs.

What will be the impact of health care reform on hospitals? Mr. Chastang expects:

- Blurring of lines between public and private hospitals;
- Public hospitals will have to compete on cost and quality basis, and many will go out of business;
- Impact on medical education as public hospitals distance themselves from the costs associated with medical education. This will strangle medical schools. There will be short term gain, but long term pain. Reduced training environments will impact on the broader community;
- Inverse relationship between care and profits. Many over-utilize the system; and
- Health care industry will be in turmoil.
