Message from the President



This month I would like to talk about Membership! Not just in AGA but in our Phoenix Chapter! But first I would like to tell you what AGA Membership has meant to me. I graduated from California State University in Hayward, California in the early 1970's. I applied for and was selected as by the U.S. Department of Health, Education and Welfare (HEW) – Internal Audit Agency in San Francisco.

Shortly before I started work, I was asked if I would consider relocating to the Las Angeles Office and was told by Regional Director (Herb Witt) that if I did not like LA he would relocate me back to SF, no questions asked. When I got to LA my Branch Manager, and still to this day my Best Friend (Sefton Boyars), introduced me to the AGA and I became active in the Chapter. I had the privilege of meeting and getting to know many people in the AGA Chapter that became my friends and who I admired for their professionalism.

A couple of years later the Federal Government decided to breakup HEW into various separate agencies and close the LA Branch and we were all looking for a job. I received a call one day from an individual (Al Clavelli) that had just been selected as the Regional Audit Manager for the U.S. Dept. of Transportation's (DOT) Internal Audit Office in San Francisco and asked if I would consider relocating back to San Francisco. Al told me that the reason he called me was because of the people he knew and respected in the AGA recommended me! So, I moved back to SF and joined the AGA San Francisco Chapter. Again, I had the privilege of meeting and getting to know many people in the AGA Chapter that became my friends and who I admired for their professionalism. A few years later, all the internal audit offices (FHWA, FAA, UMTA, USCG, etc.) within DOT became the DOT Office of Inspector General and I was promoted to be one of the three Deputy Regional Directors.

One day our Administrative Assistant came into my office and said that there was someone on the phone that wanted to talk with me, but they did not want to give her their name. At that time in my career, I was primarily responsible for all audits of the Coast Guard, which was part of DOT. I was also responsible for overseeing all the Whistle Blower Complaints and directing them to the other Deputies who were responsible for the various component agencies of DOT. I took the call and a gentleman asked if I would be willing to come over to the Holiday Inn and talk to him and another individual about a private matter.

Thinking it was a Complaint, I agreed and walked over and knocked on the room door. It turned out to be the brand-new Inspector General and Deputy Inspector General for Federal Emergency Management Agency (FEMA) and they recruited me to be their Western District Inspector General for Audits and Investigations. They advised me that I was highly recommended by a member of the AGA. I spent the rest of my career in that job until I retired in 1995!

The point of my story is, as I like to say, I only applied for one job in my life. All the other opportunities that I had came from my Membership in AGA and my participation in the various Chapters to which I have belonged. So, now for the commercial – I would like to encourage each of you to not just be a Member of the Phoenix Chapter but to get involved in any way you can in our future. We are always looking for new talent. In fact, we are in the process of updating our Bylaws and reevaluating our Committees. We need to have a Membership Committee and we can always use your help. I know we are all busy with our family, job, and life but I can tell you from experience my journey with AGA and its Chapter has been the most rewarding of all the efforts I have made. And who knows one day you can write a message for the Chapter stating what AGA has meant to you and your career!
