Year in Review

KEY ACCOMPLISHMENTS



The AGA Boston Chapter spent the morning of November 10th at Cradles to Crayons in Newton, Massachusetts. Cradles to Crayons is a not-for-profit organization that provides children from birth through age 12 living in homeless or low-income situations with essential items to thrive – at home, school, and play.

The AGA Boston Chapter held its last CEC meeting in person in June 2024. It was an excellent way for the leadership team to celebrate our accomplishments over the past year.

Education

The Boston Chapter held three major virtual events during the year, including its Virtual Fall Fraud Seminar, The Many Faces of Fraud: The Stories and Lessons We've Learned. The event included nine government and private sector speakers who provided valuable information on fraud-related topics, including financial statements and benefits fraud.

Certification

The AGA Boston Chapter launched its pilot CGFM Prep Program on March 19th. Fifteen participants participated in this program, led by a virtual instructor from AGA National, and covered all three exams. Each participant was awarded 37.5 CPEs.

Communications

The Boston Chapter has an active website and social media platforms to communicate with members and the public. For 2023, the chapter was awarded the Citizen-Centric Reporting Recognition of Excellence and the Chapter Communications Award.

Community Service




