Douglas Bass currently serves as the Chief of Emergency Services and Department Manager for the Office of Homeland Security & Emergency Management for Dallas County, Texas. For the last 25 years he has served as the Emergency Services & Homeland Security Director in the largest county government agencies in North Carolina, Virginia and Florida. His previous experience includes serving as the Emergency Services & Homeland Security Director for Miami-Dade County Government (Florida), Fairfax County Government (Virginia) and Onslow County Government (North Carolina).

He has a total of over 30 years of public safety experience as an emergency responder, law enforcement officer, fire/emergency medical service instructor and professional emergency manager. His incident command experience includes managing field command posts and emergency operations centers (EOC) for 11 major hurricanes, 4 tornadoes, multiple winter weather events, air/ground/rail transportation emergencies, urban and wild land fires, significant evacuations, special events, medical emergencies, etc. He has served as the EOC manager in 16 Presidentially Declared emergency events. Most recently he served as EOC manager for the Ebola Crisis, 2015 flooding and tornadoes that struck Dallas County.

- Should Have a Seat in EOC (PART OF FINANCE BRANCH)
- Represent Jurisdiction to Recover Expenditures with FEMA
- Track All Expenditures Categories
 - DEBRIS
 - EMERGENCY PROTECTIVE SERVICES
 - ROAD SYSTEMS
 - WATER CONROL FACILITIES
 - PUBLIC BUILDINGS AND EQUIPMENT
 - PARKS, RECREATION AND OTHER

Can It Happen Here? - Severe Weather

- December 26, 2015 Tornadoes
 - 12 Tornadoes Struck Garland, Rowlett, DeSoto, Sunnyvale and Glenn Heights.
 - 1344 Homes Were Significantly Damaged
 - 10 People Killed in Dallas County, Total of 13 in Region
 - FEMA Declaration for Public Assistance





Can It Happen Here? - Flooding

- Memorial Day (2015) Flooding
 - Historic Rainfall Event
 - Nearly 17 inches of rain fell breaking records since 1899.
 - 5 Deaths Associated with Storms
 - \$61 million dollars in Damage
 - Ten Municipalities Received Major Flooding
 - FEMA Declaration for IA and PA







It Can Happen Here - Terrorism

- June 2015 Terrorism Attack on Dallas Police Headquarters.
 - Lone Man with Armored Vehicle and Semi-automatic Weapons
 - Man Rams Police Car and Shoots at Officers and Building from Inside Vehicle
 - 4 Suspicious Bags Found on Scene, One Contained Pipe Bomb
 - Man Killed, Found Other Bombs
 Inside His Vehicle





It Can Happen Here - Disease Outbreak

- September-November 2014
 Ebola
 - National Media Event
 - 1 Death and 2 Health Care
 Workers Developed Symptoms of Ebola
 - Monitoring of Almost 200 Persons
 - Public Concern-Need for Education
 - Bentley the Ebola Dog





It Can Happen Here - All Hazards

- H1N1 (swine) flu pandemic in 2009 (first confirmed H1NI death occurred in Texas).
- Super Bowl XLV Ice Storm in Dallas/Arlington, February 2011
- Multiple Tornadoes in Dallas County in Spring of 2012.
- West Nile virus (mosquito-borne illness) with 20 deaths in Dallas County in Summer of 2012.
- Dedication of George W. Bush Presidential Center (SMU) brought the President and 4 past presidents to Dallas in May 2013.
- 50th Anniversary of President John F. Kennedy's death in Dallas, November of 2013.
- Winter Weather (Ice Storm), 800,000 without power in December 2013.
- Armed Terrorism Attack on Culwell Center in Garland in May of 2015.







What Emergency Is Next For Us?

- Earthquake
- Terrorism Event
- Critical Infrastructure Failure Such as Power Grid Failure
- Active Shooters in Government Facilities
- Transportation Emergency Such as Airplane Crash or Train Derailment
- Emerging Disease-Zika Virus
- Civil Unrest-Group Violence
