2014 will start with another opportunity to obtain low cost CPEs beginning with the AGA and ASMC joint luncheon on January 15th. Mr. Warren Anderson, Chief of Criminal Investigations in the DFAS Columbus Internal Review office will be giving a presentation and luncheon attendees can earn one CPE. In addition, there are six remaining audio conferences this program year; an increase of two from previous program years with twelve CPEs available at no cost to chapter members. The audio conferences have been heavily attended, so larger conference rooms have been secured to accommodate more people. Our next audio conferences are on December 11th, Ethics, and on January 29th, Tackling Improper Payments. These come hot on the heels of the first two audio conferences where 124 CPEs were awarded to 62 individuals.

Angel Tree:



AGA Indianapolis collected 11 boxes of school supplies; Charles Warren Fairbanks' number 1 contributor!






